# 1 Introduction

## 1.1 Purpose of this document

- 1.1.1 This Schedule of Notifications under section 102A of the Planning Act 2008 lists all persons who have been identified by the Applicant and informed of their rights under this legislation.

## 1.2 Section 102A

- 1.2.1 Section 102A states:

***Persons in certain categories may ask to become interested parties etc***

- 1) *Subsection (2) applies if—*
  - a) a person makes a request to the Examining authority to become an interested party,
  - b) the request states that the person claims to be within one or more of the categories set out in section 102B,
  - c) the person has not been notified of the acceptance of the application in accordance with section 56(2)(d), and
  - d) the applicant has issued a certificate under section 58 in relation to the application.
- 2) *The Examining authority must decide whether it considers that the person is within one or more of the categories set out in section 102B.*
- 3) *If the Examining authority decides that it considers that the person is within one or more of the categories set out in section 102B, the Examining authority must notify the person, and the applicant, that the person has become an interested party under section 102(1)(ab).*
- 4) *If the Examining authority thinks that a person might successfully make a request mentioned in subsection (1)(a), the Examining authority may inform the person about becoming an interested party under section 102(1)(ab). But the Examining authority is under no obligation to make enquiries in order to discover persons who might make such a request.*

### 1.3 Application acceptance and section 56 notification

- 1.3.1 The Development Consent Order (DCO) application for National Highways A122 Lower Thames Crossing project was accepted by The Planning Inspectorate on 28 November 2022.
- 1.3.2 In accordance with section 56 of the Planning Act 2008 the Applicant notified all prescribed persons of this acceptance in January and February of 2023.

### 1.4 Notification under section 102A

- 1.4.1 Since acceptance and notification of the application the Applicant's land referencing team has continued to undertake diligent inquiry, as described in 4.1 Statement of Reasons Annex C Land Referencing Methodology [\[APP-061\]](#).
- 1.4.2 Where this diligent inquiry informs the Applicant of a person or organisation it believes qualifies as a prescribed person under section 56, who has not previously been notified of the acceptance of the application, the Applicant has written to inform such persons that they have the opportunity to register to become an interested party.
- 1.4.3 In a limited number of cases a section 56 notification was returned by the Royal Mail, undelivered to the recipient, after the end of the notification period. In such cases the precautionary step was taken to also notify the person under section 102A, at any new address available to the Applicant.
- 1.4.4 All recipients of section 102A notifications were provided direction to the Planning Inspectorate website where this registration process is available.

## 2 Notified persons

- 2.1.1 The table below lists all persons and organisations whom the Applicant has notified under section 102A.
- 2.1.2 The listed persons will appear in the version of 4.2 Book of Reference [\[REP4-102\]](#) (BoR) subsequent to the date of notification, which will describe the location and nature of their qualifying interests.
