# 2 Helen Bowkett

#### 2.1 Profile



- 2.1.1 Helen Bowkett is the Traffic and Economics Lead on the Lower Thames Crossing and is a Senior Technical Director at Arcadis.
- 2.1.2 Helen wrote the Combined Modelling and Appraisal Report, The Traffic Forecasts: Non-Technical Summary and co-authored the Transport Assessment.
- 2.1.3 Helen has nearly 40 years' experience in the modelling and appraisal of transport schemes across rail, bus, road, cycling and walking modes. She has worked in consultancy, in local government at Kent County Council where she led on the transport modelling for new developments in North Kent, and in central government where she led on the transport modelling and appraisal of Welsh transport projects. She is the author of the Welsh Transport Appraisal Guidance and serves on the DfT's Joint Analytical Development Panel which advises the DfT on the development of their Transport Appraisal Guidance. She acted as an external reviewer for the recent revisions by Transport Scotland to the Scottish Transport Appraisal Guidance. She is a Visiting Professor at the University of the West of England and teaches on transport modelling and appraisal.
- 2.1.4 Helen holds the following qualifications: MA Philosophy, Politics and Economics from Jesus College Oxford, MSc Transport from Imperial College London and University College London, MBA Durham, MA Applied Social Research from University of the West of England, Postgraduate Certificate Spatial Data Analysis and Visualisation from UCL, PhD Transport Modelling from University of the West of England and Chartered Transport Planning Professional (CTPP). Helen is a Fellow of the Chartered institute of Highways and Transportation.
- 2.1.5 Helen has led on the transport modelling of a wide range of transport schemes including revision of North Wales rail services, proposed new rail lines and stations in North Kent, Newtown bypass, Caernarfon bypass, new M4 relief road in South Wales, Marjons bus only link road in Plymouth, an Elizabeth Line station at Woolwich and Fastrack bus rapid transit services in Kent Thameside.
