## 1 Introduction

## 1.1 Purpose of the Statement of Common Ground

- 1.1.1 This Statement of Common Ground (SoCG) has been prepared in respect of the Development Consent Order (DCO) application for the proposed A122 Lower Thames Crossing (the Project) made by National Highways Limited (the Applicant) to the Secretary of State for Transport (Secretary of State) under section 37 of the Planning Act 2008.
- 1.1.2 The SoCG has been produced to confirm to the Examining Authority where agreement has been reached between the parties named below, and where agreement has not (yet) been reached. SoCGs are an established means in the planning process of allowing all parties to identify and so focus on specific matters that may need to be addressed during the examination.
- 1.1.3 This final version of the SoCG has been submitted at Examination Deadline <u>9A</u>,

## 1.2 Parties to this Statement of Common Ground

1.2.1 This SoCG has been prepared in respect of the Project by (1) the Applicant, and (2) Stuart Mee & family (hereinafter referred to as "the landowner") which consists of:

- 1.2.2 The Applicant became the Government-owned Strategic Highways Company on 1 April 2015. It is the highway authority in England for the strategic road network and has the necessary powers and duties to operate, manage, maintain and enhance the network. Regulatory powers remain with the Secretary of State. The legislation establishing the Applicant made provision for all legal rights and obligations of the Highways Agency, including in respect of the Project, to be conferred upon or assumed by the Applicant.
- 1.2.3 The landowner owns extensive areas of land affected by the Project. The majority of this land is farmed by the Mee family business 'A.P. Mee' partnership. There are further interests, rights and assets owned by the Mee Family that are likely to be impacted by the Project.

## 1.3 Terminology

1.3.1 In the <u>final position on</u> matters table in Section <u>2</u>, of this SoCG, "Matter Not Agreed" indicates agreement on the matter could not be reached, "Matter Agreed" indicates where the issue has been resolved <u>and "Matter Agreed</u>\*" <u>indicates a matter that is agreed in principal but where further discussion may</u> <u>take place during the detailed design stage of the Project to finalise detail, or is</u> <u>subject to contract (between Stuart Mee & Family and the Applicant)</u>,

1.3.2 It is agreed that any matters not specifically referred to in Section 2 of this SoCG are not of material interest or relevance to the landowner. As such, those matters can be read as agreed, only to the extent that they are either not of material interest or relevance to the landowner. However, if new matters arise, the landowner reserves the right to comment on those matters as it considers appropriate.

# 2 Matters

## 2.1 Final Position on Matters,

- 2.1.1 Engagement between the Applicant and the landowner has been ongoing since 2017 and has continued following the submission of their Relevant Representation [RR-1021] and Written Representations, [REP1-437, REP5-125 and REP7-258 to REP7-263 inclusive]. These discussions are summarised in Annex B (entry No. 91) of the Statement of Reasons [Document Reference 4.1 (8)],
- 2.1.2 The outcome of discussions to date are presented in Table 2.1 which details and presents the matters which have been agreed, <u>matter agreed subject to detailed design or subject to contract or matter</u> not agreed, <u>between (1) the Applicant and (2)</u> Stuart Mee & Family,
- 2.1.3 At Examination Deadline <u>9A</u>, there are 21 matters in total of which one is agreed, <u>15</u>, are, agreed <u>in principle</u> and <u>five are</u> <u>not agreed</u>.
- 2.1.4 It is acknowledged there are some matters where further discussion may take place during the detailed design stage of the Project to finalise detail, or is subject to contract (between Stuart Mee & Family and the Applicant) but the matter is agreed in principle. Matters to which this applies have an asterisk (\*) next to them.

2.1.5 This is the final Statement of Common Ground between the Applicant and Stuart Mee & Family.

invironmental Statement	ES	A document produced to support an application for development consent that is subject to Environmental Impact Assessment (EIA), which sets out the likely impacts on the environment arising from the proposed development.
Public Right of Way	PRoW	A right possessed by the public to pass along routes over land at all times. Although the land may be owned by a private individual, the public may still gain access across that land along a specific route. The mode of transport allowed differs according to the type of Public Right of Way, which can consist of footpaths, bridleways and open and restricted byways.
Register of Environmental Actions and Commitments	REAC	The REAC identifies the environmental commitments that would be implemented during the construction and operational phases of the Project if the Development Consent Order is granted, and forms part of the Code of Construction Practice (ES Appendix 2.2),
