1 Introduction

1.1.1 This document sets out National Highways response to the requirement under s135(1)(b) of the Planning Act 2008 that "An order granting development consent may include provision authorising the compulsory acquisition of an interest in Crown land . . . only if the appropriate Crown Authority consents to the acquisition."

2 Section 135 Consent from the Secretary of State for the Environment, Food and Rural Affairs

Introduction

We write in response to your request for the consent of the Secretary of State of Environment, Food and Rural Affairs (the Secretary of State) in connection with the Application by National Highways. Legal title to the Land (as further defined below) is held by the Secretary of State.

The Forestry Commissioners (the Commissioners) exercise the functions of the Forestry Commission (FC), which is a Non-Ministerial Department. Forestry England (FE) is an executive agency of the FC and a Crown body, which manages and controls the public forest estate.

The Land is put at the disposal of the Commissioners pursuant to s39(1) of the 1967 Act, and managed by FE pursuant to s3(1) of the 1967 Act.

We write on behalf of the Commissioners, the Secretary of State, and on our own behalf, to confirm the basis upon which Crown Consent under s135(1) Planning Act 2008 is given to the Application, having completed the approval process under paragraph 9.2 of the Forestry Commission framework document May 2020.

Unless otherwise stated, in this letter references to "we" and "our", mean the Secretary of State, FC, and FE.



Connecting everyone with the nation's forests

Background

National Highways has applied for a Development Consent Order (**DCO**) under the Planning Act 2008 (the **Act**) for the Lower Thames Crossing, which is being examined by the Planning Inspectorate under reference TR010032 (the **Scheme**). The Scheme provides for the compulsory acquisition of land in which the Secretary of State has rights. We have considered the application documents and the book of reference, and the affected land is detailed by reference to the plot references (as contained in the Book of Reference relating to the Scheme) set out in the Annex to this letter and in the table that follows (the **Land**):

The Scheme further provides for land to be transferred at nil cost to the Secretary of State and put at the disposal of the Commissioners pursuant to s39(1) of the 1967 Act, and



managed by FE pursuant to s3(1) of the 1967 Act as set out below and in the Annex (the Replacement Land).

Section 135(1) of the Act provides that an order granting development consent may include provision authorising the compulsory acquisition of an interest in Crown land only if it is an interest which is for the time being held otherwise than by or on behalf of the Crown and the appropriate Crown authority consents to the acquisition.

Section 135(2) states that an order granting development consent may include any other provision applying in relation to Crown land, or rights benefiting the Crown, only if the appropriate Crown authority consents to the inclusion of the provision.

Consent under both section 135(1) and (2) is required for the Scheme.

Powers of the Secretary of State

In relation to any disposal of land, the Secretary of State must consider its balancing duties under section 1(2) of the 1967 Act, to achieve a reasonable balance between "the development of afforestation, the management of forests and the production and supply of timber" (section 3A(a) 1967 Act) and the conservation and enhancement of natural beauty



and the conservation of flora, fauna and geological or physiographical features of special interest" (section 3A(b) 1967 Act).

Under s.39(1) of the 1967 Act, the Secretary of State can acquire land suitable for afforestation or forestry-related purposes through purchase, lease, or exchange. Section 39(2) of the 1967 Act authorises the Secretary of State to dispose of land.

Consent

We have considered our respective obligations, including those outlined above, and in consideration of the transfer of the Replacement Land, in return for the disposal of the Land for the Uses, hereby give consent to the Application for the Scheme pursuant to s135(1) and (2) of the Act.

Upon the basis outlined in this letter, we hereby agree the drafting of Article 43 of the draft DCO.
