1 Response to Rule 8(3) and 9 letter of 17 November 2023

- 1.1.1 This submission is in response to the Rule 8(3) and 9 letter [PD-049] issued by the Examining Authority on 17 November 2023 giving details of changes to the Examination Timetable.
- 1.1.2 Annex A of this letter identifies all of the documents that accompany this submission.
- 1.1.3 A Navigation Document [**Document Reference 1.4 (16)**] has been provided with this submission.

1.2 Final Statements of Common Ground (SoCGs)

- 1.2.1 The Applicant refers the Examining Authority to Annex B which provides a schedule and status of the final SoCGs submitted (or not) at Deadline 9A which includes:
 - a. Updates to those SoCGs submitted with the Development Consent Order (DCO) application on 31 October 2022
 - b. New SoCGs prepared with Interested Parties in response to the Rule 6
 Letter [PD-013]
 - c. Additional SoCGs with further Interested Parties that were not submitted with the Application, or requested in the Rule 6 Letter [PD-013], but which the Applicant feels will assist the Examining Authority
- 1.2.2 All updated SoCGs are presented as 'Final' and have been included in 'tracked changes' and 'clean' versions.

- 1.2.3 In total, SoCGs with 73 Interested Parties have been submitted into the Examination and 72 have been submitted as 'Final' iterations either before or at Deadline 9A.
- 1.2.4 In agreement with the Port of Tilbury London Limited (PoTLL), the Applicant has not included that Final SoCG as the parties are still in active negotiations on a side agreement that is close to being settled, which would in turn inform the final position of several matters. To give the Examining Authority the most up-to-date positions at the close of Examination, this Final SoCG, reflecting the agreed positions will be submitted at Deadline 10.
- 1.2.5 In addition to the SoCGs, the Applicant has also submitted a Final Statement of Commonality [**Document Reference 5.3 (10)**] at this deadline.
- 1.3 Any further information requested by the ExA under Rule 17 of the Infrastructure Planning (Examination Procedure) Rules 2010 (EPR)

 Procedural Decision 45
- 1.3.1 On 8 December 2023, the Examining Authority issued Procedural Decision 45 [PD-051] to seek further information about the designation of 'The Wilderness' under Rule 17 of the EPR. Within this Procedural Decision there were several questions directed to the Applicant to be submitted at Deadline 9A.
- 1.3.2 The Applicant has responded to this within Applicant's response to Procedural Decision 45 The Wildness [**Document Reference 9.224**].
- 1.3.3 The Applicant notes that it may respond at Deadline 10 to the material provided by Natural England at Deadline 9A.

2 Other

- 2.1 Section 135 Consent from the Secretary of State for the Environment, Food and Rural Affairs
- 2.1.1 The Applicant can confirm that the Secretary of State (SoS) for the Environment, Food and Rural Affairs has granted the Crown's consent under section 135 of the Planning Act 2008 in relation to land owned by the Forestry Commission and managed by Forestry England being (i) parts of Thames Chase Community Forest near North Ockendon and Great Warley and (ii) Jeskyns Community Woodland near Cobham, Kent. This is enclosed with this submission with as Letter of Confirmation SoS Environment, Food and Rural Affairs (Crown Land) [Document Reference 9.223].
- 2.2 Response to third written questions (ExQ3)
- 2.2.1 It was requested in the Examining Authority's third written questions and requests for information (ExQ3) [PD-046], for a limited number of questions, for the Applicant to provide updates or nil returns at each successive deadline.
- 2.2.2 **Q2.1.1 A47 Judicial Challenges in the Court of Appeal**: requests that, at each successive deadline until the closure of the Examination, a position statement be submitted explaining any changes to the circumstances of this litigation. If there is no change, then nil return should be entered.





- 2.2.3 The Applicant can confirm nil return in response to this question at Deadline 9A.
- 2.2.4 **Q4.2.2 River access and jetties for construction**: requests that, at successive deadlines, the ExA be kept informed of any changed positions emerging from ongoing discussions with the Port of London Authority (PLA) in regard to use of river transport.
- 2.2.5 The Applicant can confirm nil return in response to this question at Deadline 9A, and that the response included within the Deadline 9 Cover Letter [**Document Reference 9.210**] remains the current position.
- 2.3 Stakeholder Actions and Commitments Register (SAC-R)
- 2.3.1 The SAC-R was discussed at ISH12 and a number of points were raised by some of the local authorities in attendance. Subsequently the Applicant has continued its engagement with these stakeholders, resulting in updates to the SAC-R. These are:
 - a. An update to SACR 025 to respond to comments from Gravesham Borough Council on the replacement recreational area north of Thong Lane.
 - b. The London Borough of Havering submitted some detailed points upon Part 2 (the Skills, Education and Employment Strategy) and Part 3 (Community Funds) in document [REP8 -151], including a number of proposed changes to the wording of those parts. Where appropriate, the Applicant has accepted some of the revised wording proposed by the London Borough of Havering in the version of the SAC-R submitted at deadline 9A. The Examining Authority and Interested Parties should therefore consider the Deadline 9A version of the Stakeholder Actions and Commitments Register [Document Reference 7.21 (8)] as the final version.
- 2.3.2 This document has been included in 'tracked changes' and 'clean' versions.

2.4 References to the Examination Library

2.4.1 It has not been possible to update all cross-references to the Deadline 9 references in the Examination Library – i.e. '[REP9-XXX]' as the Examination Library had not yet been updated by 11am on the Deadline 9A deadline day. The Applicant has therefore referred to its document numbering system in the document, i.e. '[Document Reference 9.XXX]'.
