I am writing about my Grans home [REDACTED]

**My Gran has lived in her home for over 55 years. As a small and close family this home means the world to us, especially my mum, gran and me.**

**My gran has lived many years in doubt about whether her home will stand or be knocked down. I believe this has gone on for longer than I have been alive (26 years). This has honestly destroyed my gran's life, it is now destroying my mums and now mine. My gran is terrified of having work done on her home in case it gets knocked down! How is that fair on an elderly lady who should be enjoying every moment. Also how is this fair for any of us?**

**It is unbelievably disgusting that for all these years she has had to live not knowing if she will have her home. What I do question is what is my gran's human rights? She owns this home and land, surely she has rights!!!**

**In addition, my grans home is not actually on the road. It is just on the edge. So why can it not be saved? Why do you have to knock her home down?**

**I have personally been dealing with Highways myself. My gran should not have to deal with this which is why I have taken the stress on. [REDACTED] this is purely because of this road. I am now having to support my gran and my poor mother. Highways have been absolutely shocking. They have told me on several occasions they would ring with updates... they never have. They told me months ago they would confirm whether they could save my grans house. They did not mention about assessing her home!!! They have NOT contacted us. This is not helping [REDACTED]. She honestly panics every time the post comes and wonders if it is from Highways. I would like for one of you to walk in my shoes for one day!!**

**Why knock someone's home down when you do not need to? Why take green land when you do not need to?**

**I am honestly disgusted about the treatment of my family. I am so fed up with dealing with this now, while working full time and having to keep this quiet from other people! Honestly, would you like to deal with this?**
