1. Introduction

- 1.1.1 This Schedule of Progress relates to an application made by National Highways (the "Applicant") to the Planning Inspectorate under the Planning Act 2008 (the "2008 Act") for a Development Consent Order ("DCO"). If made, the DCO would grant consent for the Applicant to undertake the A57 Link Roads improvement scheme (the "Scheme").
- 1.1.2 This document has been prepared in response to Question 15.12 of the Examining Authorities questions (PD-009) in relation to the Applicant's discussions with Statutory Undertakers around s127 and s138 of the Planning Act 2008. The question asks:
 - "At each of the relevant Deadlines shown in the Examination timetable, please will the Applicant provide a schedule of progress in relation to each Statutory Undertaker where s127 and/ or s138 of the PA2008 applies and that sets out:
 - a) an up-to-date list of Statutory Undertakers
 - b) the nature of their undertakings;
 - c) the Statutory Undertaker's land, rights or apparatus that would be affected and how it would be affected;
 - d) the progress made in discussions with Statutory Undertakers since the last update in relation to the tests set out in s127(3)(a) or (b), s127(6)(a) or (b) and s138(4) of the PA2008;
 - e) any agreement or differences between the Applicant and the Statutory Undertaker about whether the tests have been met, the next steps to be taken, and the progress anticipated by the close of the Examination. The above information will be published on our website, so commercial and/or confidential details need not be given."
- 1.1.3 The applicant will continue to engage with relevant statutory stakeholders as the examination progresses.



2. Statutory Undertaker Schedule

- 2.1.1 The schedule in Table 2.1 provides a schedule of progress in relation to each Statutory Undertaker where s127 and/or S138 of the Planning Act 2008 applies.
- 2.1.2 It illustrates each plot of land related to each Statutory Stakeholder, identifies its nature of undertakings, the land, rights or apparatus that would be affected. It provides an update on the progress made in discussions and any agreements or differences that each Statutory Stakeholder has with National Highways.
- 2.1.3 This Schedule has been submitted at Deadline 9 of the examination progresses.
