1. Purpose of this Document

- 1.1.1. This document provides a register of the key changes made to the A57 Link Roads Environmental Statement (ES) (including supporting figures and appendices) since the original application was submitted to the Planning Inspectorate on 28 June 2021 and accepted for examination on 26 July 2021.
- 1.1.2. Since submission, several of the original ES chapters and supporting documents and figures have been revised, with a number of new versions submitted during the Development Consent Order (DCO) examination.
- 1.1.3. Note: minor changes such as consistency updates or typos are not outlined in this document.
- 1.1.4. This is a live document and will be updated throughout the examination period and submitted each time the ES is updated.
