# 1. Introduction

## 1.1. Purpose of this document

- 1.1.1. This document provides a guide to National Highways' A57 Link Road Development Consent Order (DCO) application pursuant to the Planning Act 2008. The original application was submitted to the Planning Inspectorate on 28 June 2021 and accepted for examination on 26 July 2021.
- 1.1.2. Since submission, several of the original documents have been revised, with a number of new documents submitted. This guide charts the submission of these documents to the Planning Inspectorate. This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline.

## 2. Document tracker

### 2.1. Master document list

2.1.1. This section presents the master document list, which provides a list of all documents submitted to date, indicating either the latest revision (if applicable) or when a new document was submitted. The documents are grouped by volume, as shown in Table 2-1.

The volume also contains the document setting out the position regarding other consents and agreements 5.
4 – Compulsory acquisition information	Documents, including the Book of reference and the Statement of reasons, which set out the land to be acquired or used, and justification for the seeking of compulsory acquisition powers over this land and evidence to support the availability of funding to deliver the Scheme.
5 – Reports / Statements	Documents including the Consultation report and its associated appendices describing the methodology and outcomes of the consultation undertaken between 2016 and 2020 and how responses to the consultations and the opinions expressed have been taken into account.  In addition, this volume includes other environment related documents including a Statement on statutory nuisance, Water Framework Directive assessment,

	Habitat Regulations assessment, Flood risk assessment and an Equality Impact Assessment.
6 – Environmental impact assessment (EIA) information	An assessment of the likely significant effects (both positive and negative) of the Scheme on the environment and a description of mitigation measures proposed to reduce any negative impacts. This volume contains the Environmental Statement chapters, figures and appendices.
7 – Other documents	Additional documents that support the DCO application; these are not legally required but provide useful information, including the Case for the Scheme and schedule of accordance with National Policy Statement, a Transport assessment report, a Register of Environmental Actions and Commitments and an Outline Construction Environmental Management Plan (CEMP).
8 – Statements of common ground	Joint statement to confirm those matters which are agreed.
9 – Additional submissions	New documents submitted to the Planning Inspectorate during pre-Examination and examination.
