#### 3 CONSULTATION

#### 3.1 Consultation Undertaken To-Date

#### Non-Statutory Consultation

- 3.1.1 A public non-statutory consultation ran for 6 weeks from 5 September to 17 October 2016 at the options stage. Publicity and documentation for the consultation related to a number of Scheme options. This included:
  - 2,300 consultation brochures with questionnaires distributed to deposit points, key stakeholders and properties closest to the Scheme
  - 21,000 flyers distributed to properties within 500m of the A585 corridor from the M55 to Fleetwood and the other main local routes leading to the A585
  - Notices published in 3 local newspapers
  - Documents, fly-through video and questionnaires on the Highways England website
- 3.1.2 Three public exhibition events were also held during the consultation period in 2016:
  - Friday 16 September, 2pm 8pm Singleton Village Hall, Station Road, Singleton, FY6 8LL
  - Saturday 17 September, 10am 4pm Singleton Village Hall, Station Road, Singleton, FY6 8LL
  - Wednesday 21 September, 4pm 8pm Wyre Civic Centre, Breck Road, Poulton-le-Fylde, FY6 7PU
- 3.1.3 As noted above the 2016 consultation was a non-statutory consultation. This means that there was no statutory basis or requirement for the consultation, and consequently there were no rules or requirements under legislation that the consultation had to meet. Instead, in carrying out the consultation Highways England was influenced by government guidance on consultation, best practice and lessons learned from other major consultations, and the principles for a lawful consultation that have been established by the courts.
- 3.1.4 The Preferred Route Announcement (PRA) was made on 24 October 2017. Statutory Consultation
- 3.1.5 A statutory consultation ran for 7 weeks from 21 March to 8 May 2018 in accordance with the Statement of Community Consultation <a href="https://highwaysengland.citizenspace.com/he/a585-windy-harbour-to-skippool-statutory-consultat/">https://highwaysengland.citizenspace.com/he/a585-windy-harbour-to-skippool-statutory-consultat/</a>. Publicity and documentation for the consultation included:
  - 2,300 consultation brochures with questionnaires distributed to deposit points, key stakeholders and properties closest to the Scheme
  - 25,000 flyers distributed
  - Notices published in 4 local newspapers
  - Documents, fly-through video and questionnaires on the Highways England website



- A Preliminary Environmental Information Report (PEIR) and associated Non-Technical Summary
- 3.1.6 Four public exhibition events were also held during the consultation period in 2018:
  - Friday 23 March 2018, 2pm 8pm, Singleton Village Hall, Station Road, Singleton, FY6 8LL
  - Saturday 7 April 2018, 10am 4pm, Singleton Village Hall, Station Road, Singleton, FY6 8LL
  - Tuesday 10 April 2018, 3pm 8pm, Wyre Civic Centre, Breck Road, Poultonle-Fylde, FY6 7PU
  - Wednesday 11 April 2018, 1pm 7pm, Fleetwood Nautical Campus, Broadwater, Fleetwood, FY7 8JZ
- 3.1.7 An additional statutory consultation event was also undertaken between August and September 2018. This was to ensure that the commitment in the Statement of Community Consultation that all members of the public who had previously contacted Highways England regarding the A585 Windy Harbour to Skippool Improvement Scheme received the public consultation brochure.
- 3.1.8 Further details of the statutory consultation process and the feedback received is outlined within the Consultation Report (document reference TR010035/APP/5.1).
- 3.2 Environmental Consultation Undertaken To-Date
- 3.2.1 During the preparation of the Environmental Statement (ES) a number of topic specific consultations have been undertaken with various organisations as part of the baseline data gathering and assessment process (both with statutory and non-statutory consultees). This information is presented within Table 3-1.
