**A585 Windy Harbour to Skippool Improvement Scheme**

**Applicant's Submission at Deadline 1**

Please find enclosed, in accordance with the Examination Timetable, the Applicant's submissions to the Examining Authority in respect of Deadline 1, namely:

- 1 The Applicant's comments on Relevant Representations (**Document reference TR010035/APP/7.9**); and
- 2 The Applicant's draft itinerary for the Accompanied Site Inspection (**Document reference TR010035/APP/7.8**). Please note that, within the draft, we have identified certain parking points. Some of these are on land which is accessible but in private ownership. We will therefore need to secure the relevant permissions from the owners of the land before fixing the parking points.

In preparing our comments on the Relevant Representations, we have had regard to the Combined Modelling and Appraisal Report which was prepared for the Scheme. We believe it would be beneficial for the Examining Authority and Interested Parties to have sight of the report and accordingly enclose a copy (**Document reference TR010035/APP/7.12**).

In order to assist the Examining Authority and Interested Parties to navigate the Applicant's submissions and to explain where application documents are superseded, the Applicant has prepared an Application Document Tracker (**Document reference TR010035/APP/1.4**), which is enclosed. The Tracker will be updated at each deadline.

Finally, the Applicant has sought to conclude Statements of Common Ground (SOCG) with each of the parties identified by the Examining Authority and listed in Annex B of the Rule 8 Letter. A statement setting out the current position with each is enclosed

(**Document reference TR010035/APP/7.7**). You will see that four have been concluded and are enclosed:

- 1 Historic England (**Document reference TR010035/APP/8.6**);
- 2 Electricity North West (**Document reference TR010035/APP/8.11**);
- 3 Openreach (BT Plc) (**Document reference TR010035/APP/8.13**); and
- 4 GTC (**Document reference TR010035/APP/8.15**).
