1.0 Notification by the MMO to remain an Interested Party by the ExA

The MMO has an interest in this project because the works, as detailed within the Environmental Statement (ES), appear to include construction activities which are proposed to take place within the UK Marine Area as defined by Section 42 of the Marine and Coastal Access Act 2009 (MCAA 2009) – The Development Consent Order (DCO) application includes a draft Deemed Marine Licence (DML) under Section 65, MCAA. Should consent be granted for the project, the MMO will be responsible for monitoring, compliance and enforcement of DML conditions.

2.0 Revised/updated Statement of Common Ground

- 2.1. The MMO noted as part of the Deadline 3 response a number of requirements prior to sign-off of the SoCG. This included an updated DML containing coordinates. An updated DML has not yet been received.
- 2.2 The MMO also noted as part of the Deadline 3 response that a number of issues remained with Natural England and the Environment Agency. MMO are yet to have sight of agreement with these bodies.
- 2.3 Given the above, the MMO is unable to fully agree an updated Statement of Common Ground at this stage.
