No.4: Article 29 – Temporary use of land for carrying out the authorised development

The Applicant is requested to specifically identify the plots over which they intend to CA new rights in a separate Schedule in the DCO and amend Articles 23 and 29 to ensure that those plots over which they are not seeking any CA are specifically excluded from the scope of CA.

The Applicant is requested to provide a list of all persons they have contacted with their relevant plot numbers and forward the "limited responses" they have received to their recent correspondence.

Persons with an interest in the land listed in Schedule 7 of the Draft Development Consent Order [REP5-008] are requested to submit their comments on the Applicant's proposals

No.7: Mr Michael Buckley's concerns regarding covering of the culvert [REP6a-003]

The ExA notes that in response to Mr M Buckley's concerns concerning safety of the dyke the Applicant has agreed to provide a close boarded fence between the Scheme and access to the dyke. Mr M Buckley is requested to submit his comments on the Applicant's proposal.

Statutory Undertakers: land or rights

The Applicant and Statutory Undertakers are requested to submit their cases on the tests in sections 127 and 138 by **Deadline 9** so that there will be time for parties to comment on this before the end of examination.

Night-time working

Can the Applicant clarify how the CEMP will regulate night-time working (as suggested in comments on written representations received at Deadline 3 [REP4-022])?

Report on the Implications for European Sites (RIES)

Can the Applicant confirm how the shooting rights, in relation to the Bird Mitigation Strategy, will be secured within the DCO?

Responses to all the above are required by **midday on Monday 7 October 2019 (Deadline 9)**.
