## 2 Statements of Common Ground

Since Deadline 7, the Applicant has agreed the Statement of Common Ground with Natural England which is enclosed.

The Applicant has further agreed a Statement of Common Ground with Lancashire County Council. Unfortunately, the signatory for the Council has been unavailable and will not sign the statement until tomorrow at the earliest. We therefore enclose a copy of the agreed statement to assist the Examining Authority and will submit the signed version as soon as it is available.

The Applicant has also engaged with the parties with whom a Statement of Common Ground has yet to be completed and encloses a document setting out the progress made with each (Document reference TR010035/APP/7.7).

In respect of Cadent Gas Ltd, we confirm that it has not yet been possible to conclude a Statement of Common Ground. Progress has been made in respect of the draft protective provisions requested by Cadent, although it has not been possible to agree all points. The Applicant has accordingly included in the draft Development Consent Order, submitted at this deadline, the protective provisions insofar as they have been agreed and encloses a statement summarising the Applicant's position in respect of those points which it has not been possible to agree (document reference TR010035/APP/7.33).

## 3 Response to Further Representations

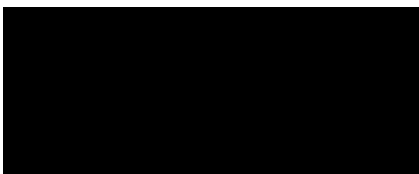
The Applicant's responses to the Representations received at Deadline 7 are enclosed (Document reference TR010035/APP/7.32).
