We write with respect to the comments made by Highways England in reply to representations received at deadline 6 and 6A. Under reference REP6a-003.3 we note that the Environmental Master Plan now shows a fence the majority of which will be 1.8 metres high with approximately 10 metres at 1.2 metres high along the line requested by our client. We have now spoken to HE and our client would be pleased if Highways England can confirm that there is a definite commitment to build a close boarded fence along the line indicated and that it would be 1.8 metres for its full length. We believe the reduction of part of the fence to 1.2 metres high will leave a health and safety issue. Provide Highways England can confirm a definite commitment to construct this fence our client will have no further comments regarding the same.
