Dear Charm,

I appreciate that at first glance the Joint Representation appears to be a summation of the separate representations from each of the three parish councils, but this is not the case.

The Joint Representation contains vitally important information on the steps taken by the Joint PCs to prove, technically, the viability of their joint request to have the Hazelgrove Junction simplified and the existing A303 retained as a local road.

This Representation also contains details of the Consulting Engineer and Design Consultancy retained at the expense of the Joint Councils, projections of the potential cost of further design work and a specific request to the Inspector to require H.E. to formally investigate and consult on the requested design changes.

None of this detail is in any of the three separate submissions.

It is our further intention to follow up this Joint Representation with detailed professional standard CAD drawings (currently being prepared) as evidence that both the design changes mentioned above are viable and should be considered.

Without the Joint Representation the 'vehicle' for this follow up information is effectively removed and any further submissions will appear 'disjointed' and unprofessional to the Inspector.

On behalf of the Joint Councils can I ask that you reconsider your decision and allow the Joint Representation to go forward or provide an opportunity for each parish council to modify its Representation?

To exclude this information would effectively negate the collective voice of local people and prejudice the DCO process.
