## **1** Guide to the Application

### 1.1 Purpose of this document

- 1.1.1 This document provides a guide to Highways England's A303 Sparkford to Ilchester Dualling Development Consent Order (DCO) application. The original application was submitted to the Planning Inspectorate on 27 July 2018 and accepted for Examination by the Examining Authority on 23 August 2018.
- 1.1.2 Since the DCO submission a number of the original application documents have been revised and new documents produced, and this will continue throughout the DCO Examination. This guide provides a list of the latest documents submitted at Deadline 7.
- 1.1.3 This is a live document and will be updated throughout the rest of the Examination period and submitted for each deadline.
