1. INTRODUCTION

- 1.1.1. The Hedgerow Plans (the "Plans") relate to an application made by Highways England (the "Applicant") to the Secretary of State of Transport, via the Planning Inspectorate (the "Inspectorate") under Section 37 of the Planning Act 2008 (PA 2008) for a Development Consent Order (DCO). If made, the DCO would grant consent for the A47/A11 Thickthorn Junction (the "Scheme"). A detailed description of the Scheme can be found in Chapter 2: The Proposed Scheme of the Environmental Statement (ES)(TR010037/APP/6.1)
- 1.1.2. The Plans comprise part of the suite of application documentation and are included in the application in compliance with Regulations 5(2)(o) and 5(4) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the "2009 Regulations"), which requires:


5(2)(o) "any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings and structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided and means of landscaping".

5(4) "where a plan comprises three or more separate sheets a key plan must be provided showing the relationship between the different sheets".

1.1.3. As the Plans are part of the application documentation, they should be read alongside and are informed by the other application documentation. In particular, the Plans should be read alongside Schedule 8 of the draft DCO (TR010037/APP/3.1) and the Works Plans (TR010037/APP/2.4).
