# 1 INTRODUCTION

# 1.1 Purpose of this Document

- 1.1.1 This Statement of Commonality for Statements of Common Ground ("this Statement") relates to an application made by Highways England ("the Applicant") to the Planning Inspectorate ("PINS") under Section 37 of the Planning Act 2008 ("PA 2008") for a Development Consent Order ("DCO"). If made the DCO would grant consent for the Applicant to undertake the A47/A11 Thickthorn Junction ("the Scheme"). A detailed description of the Scheme can be found in the Environmental Statement Chapter 2 The Proposed Scheme (APP-039).
- 1.1.2 This Statement has been prepared to provide the Examining Authority ("ExA") with the current position on Statements of Common Ground ("SoCG") between Highways England and prescribed consultees, statutory undertakers and interested parties ("other parties") in relation to the Scheme.
- 1.1.3 This Statement also provides a current position on the commonality on specific points in the various SoCGs at Examination Deadline 1 (13 October 2021).
- 1.1.4 This Statement will be updated and submitted at subsequent Examination Deadlines as necessary.



# 2 STRUCTURE OF STATEMENTS OF COMMON GROUND

- 2.1.1 To ensure consistency in the approach taken to documenting matters agreed, matters subject to further negotiation or matters not agreed, each of the SoCGs adopts a standard format in order to provide clarity to other parties and ultimately the ExA.
- 2.1.2 Each SoCG has the following structure:
  - Section 1: provides an introduction to the SoCG and a description of its purpose.
  - Section 2: states the engagement that has occurred between the Applicant and the relevant party.
  - Section 3: sets out any issues that have arisen, reporting on the status of each issue, i.e. whether it is agreed, still under discussion or not agreed, and any remaining actions.
  - Appendices which contain any relevant document not forming part of the application that are referenced in the SoCG (e.g. emails / meeting notes / data).



# 3 LIST OF STATEMENTS OF COMMON GROUND

- 3.1.1 The Applicant has begun to prepare SoCGs with a number of prescribed consultees, statutory undertakers and other parties it considered beneficial to do so following acceptance to Examination.
- 3.1.2 SoCGs with further specific parties were also requested by the ExA through the Rule 6 letter dated 20 August 2021 and the Rule 8 letter dated 23 September 2021.
- 3.1.3 The parties which the Applicant is exploring the possible need for SoCGs are listed in Table 3-1 below. Further detail about the current position of each SoCG can be found at Section 4, Table 4-1 of this Statement.

# 4 SUMMARY OF CURRENT POSITION

- 4.1.1 This section provides the current position of each SoCG as at Deadline 1. As final versions of the SoCGs are agreed as the DCO Examination progresses, they will be submitted alongside this Statement.
- 4.1.2 Table 4-1 provides a high-level position and where necessary includes further detail to aid understanding of the ExA. The high-level positions used in the table are:
  - Final Signed SoCG all matters agreed The final SoCG has been signed by both parties and all matters are agreed.
  - Final Signed SoCG with matters outstanding The final SoCG has been signed by both parties, and there remain matters outstanding, that the Applicant and the other party agree, will not be resolved during the Examination.
  - Draft SoCG The SoCG has been drafted by the Applicant, it has been shared with the other party and comments have been provided. Discussion is ongoing to reach a 'Final Signed SoCG all matters agreed' or 'Final Signed SoCG with matters outstanding'.
  - SoCG drafted and shared with other party The SoCG has been drafted by the Applicant and shared with the other party, but awaiting comments to be provided before issue as 'SoCG in draft' to the Examining Authority. The SoCG will be provided at the earliest opportunity.
  - SoCG under preparation The SoCG to be drafted by the Applicant subject to on-going discussions with the other party. The SoCG or position statement on why SoCG not needed will be provided at the earliest opportunity.





## 6 POSITION AT DEADLINE 1

### 6.1 Introduction

- 6.1.1 This section provides the ExA with a summary of the current position at Deadline 1 between the Applicant and each party. The individual SoCG should be referred to for the full detail on specific matters.
- 6.1.2 For the statutory undertakers in Section 6.4, the Applicant and the parties are focusing on seeking agreement of the Protective Provisions and/or (where relevant) a side agreement, unless it is agreed with the statutory undertaker that a SoCG is required.

# 6.2 Statutory Environmental Bodies

# **Natural England**

- 6.2.1 The position of Natural England at Deadline 1 is currently Under Discussion.
- 6.2.2 A draft SoCG is being developed between the Applicant and Natural England. The draft reflects the issues raised during statutory consultation and meetings/correspondence on the development of the Scheme design and Environmental Statement. The Applicant is awaiting comments from Natural England on the SoCG but notes that Natural England have not submitted a Relevant Representation.
- 6.2.3 The Applicant and Natural England will continue discussions and aim to reach agreement on any outstanding points.

## **Environment Agency**

- 6.2.4 The position of Environment Agency at Deadline 1 is currently Under Discussion.
- 6.2.5 A draft SoCG is being developed between the Applicant and the Environment Agency. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of the Scheme design and Environmental Statement; following receipt of the Relevant Representations.
- 6.2.6 The Applicant will continue to engage with the Environment Agency to gain agreement on these and any further matters.

# **Historic England**

- 6.2.7 The position of Historic England at Deadline 1 is currently Under Discussion.
- 6.2.8 A draft SoCG is being developed between the Applicant and the Historic England. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of the Scheme design and Environmental Statement; following receipt of the Relevant Representations
- 6.2.9 The Applicant will continue to engage with the Historic England to gain agreement on these and any further matters.



# 6.3 Local Authorities

# **Norfolk County Council**

- 6.3.1 The position of Norfolk County Council (NCC) at Deadline 1 is currently Under Discussion.
- 6.3.2 A draft of the SoCG is being developed between the Applicant and NCC. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of Scheme design and Environmental Statement; following receipt of the Relevant Representations; and during discussions on issues during September 2021.
- 6.3.3 The Applicant will continue to engage with NCC to gain agreement on these and any further matters.

### **South Norfolk Council**

- 6.3.4 The position of South Norfolk Council (SNC) at Deadline 1 is currently Under Discussion.
- 6.3.5 A draft of the SoCG is being developed between the Applicant and SNC. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of Scheme design and Environmental Statement; following receipt of the Relevant Representations.
- 6.3.6 The Applicant will continue to engage with SNC to gain agreement on these and any further matters.

# 6.4 Prescribed Bodies – Statutory Undertakers

# **National Grid Electricity Transmission Plc**

- 6.4.1 The position of National Grid Electricity Transmission Plc (NGET) at Deadline 1 is currently Under Discussion.
- 6.4.2 Discussions are ongoing and focussed on protective provisions and access to existing infrastructure. The draft reflects the issues raised during meetings/correspondence on the development of Scheme design and following receipt of the Relevant Representations.
- 6.4.3 The Applicant will continue to engage with Cadent gas on any further matters that arise.

#### **Network Rail Infrastructure Limited**

- 6.4.4 The position of Network Rail Infrastructure Limited (NRIL) at Deadline 1 is currently Under Preparation.
- 6.4.5 Discussions are ongoing and focussed on the extent to which the Scheme might impact on NRIL assets.
- 6.4.6 The Applicant will continue to engage with Cadent gas on any further matters that arise.



#### **Cadent Gas**

- 6.4.7 The position of Cadent Gas at Deadline 1 is currently Under Discussion.
- 6.4.8 Discussions are ongoing and focussed on protective provisions and diversions of existing infrastructure. A form of protective provisions has been agreed and discussions are ongoing in relation to the development of the design and construction methodology for diverting the low pressure gas pipeline in advance of the main works and securing access to Cadent assets. The draft reflects the issues raised: during meetings/correspondence on the development of Scheme design and following receipt of the Relevant Representations.
- 6.4.9 The Applicant will continue to engage with Cadent gas on any further matters that arise.

# **Anglian Water**

- 6.4.10 The position of Anglian Water Limited at Deadline 1 is currently Under Discussion.
- 6.4.11 Discussions are ongoing and focussed on protective provisions and diversions and protection of existing infrastructure. Discussions are ongoing in relation to the development of the design and construction methodology for diverting the fresh and foul water services in advance of the main works. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of Scheme design and following receipt of the Relevant Representations
- 6.4.12 The Applicant will continue to engage with Anglian Water Limited on any further matters that arise.

## 6.5 Other Interested Parties

### **Big Sky Developments Ltd**

- 6.5.1 The position of Big Sky Developments Limited at Deadline 1 is currently Under Discussion.
- 6.5.2 Discussions are ongoing and focussed on environmental mitigation, construction phasing and alternative solutions for the on-site public open space allocation. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of Scheme design and following receipt of the Relevant Representations.
- 6.5.3 The Applicant will continue to engage with Anglian Water Limited on any further matters that arise.
