1. INTRODUCTION

- 1.1.1. The Location Plan (the "Plan") relates to an application made by Highways England (the "Applicant") to the Secretary of State of Transport, via the Planning Inspectorate (the "Inspectorate") under Section 37 of the Planning Act 2008 (PA 2008) for a Development Consent Order (DCO). If made, the DCO would grant consent for the A47/A11 Thickthorn Junction Scheme (the "Scheme"). A detailed description of the Scheme can be found in Chapter 2: The Proposed Scheme of the Environmental Statement (ES)(TR010037/APP/6.1)
- 1.1.2. The Plan comprises part of the suite of application documentation and is included in the application for a DCO in compliance with Regulations 5(2)(o) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the "2009 Regulations"), which require:


5(2)(o) "any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;"

- 1.1.3. Although Regulation 5(2)(o) does not expressly mention location, the Planning Inspectorate's Advice Note Six: Preparation and submission of application documents (February 2016: Version 7) suggests (at Appendix 1) that an application for development consent may include the submission of a location plan.
- 1.1.4. Therefore, the Plan has been included in the application documentation to identify the location of the Scheme in its wider geographical context. The Plan uses a smaller scale than prescribed in Regulation 5(3) of the 2009 Regulations, to enable the wider geographical context to be represented on a single sheet plan.
- 1.1.5. As the Plan is part of the application documentation, it should be read alongside and be informed by the other application documentation.
