Application by National Highways Limited ("the Applicant") for an Order granting Development Consent for the A47/ A11 Thickthorn Junction

REQUEST FOR COMMENTS FROM THE APPLICANT; NORFOLK COUNTY COUNCIL; NATURAL ENGLAND; HISTORIC ENGLAND; HORNSEA PROJECT THREE OFFSHORE FARM.

The Examining Authority submitted on 20 June 2022 a Report and Recommendation in respect of its findings and conclusions on the above application to the Secretary of State for Transport ("the Secretary of State"). In accordance with section 107 of the Planning Act 2008, the Secretary of State has until 20 September 2022 to make a decision on the application. The Secretary of State invites comments in relation to the following matters which were outstanding at the end of the Examination

1 Climate Change

The Secretary of State notes the Norfolk Local Transport Plan 4 ("the Plan") is due to be adopted in July 2022. In anticipation that is it adopted, the Secretary of State invites the Applicant to provide an assessment against the carbon targets contained within the Plan.



The Secretary of State also requests that Norfolk County Council confirm if the Plan has been adopted, and if not when it is expected to be adopted.

2 Statements of Common Ground ("SoCGs")

The Secretary of State notes that at the end of the examination SoCGs had not yet been signed between the **Applicant** and **Historic England**, **Natural England and Hornsea Project Tree Offshore Wind Farm**. Please could the parties confirm the status of these SoCGs and if these have been signed.

The deadline for any response is 8 August 2022
