#### 1 INTRODUCTION

### 1.1 Purpose of this Document

- 1.1.1 This Statement of Commonality for Statements of Common Ground ("this Statement") relates to an application made by Highways England ("the Applicant") to the Planning Inspectorate ("PINS") under Section 37 of the Planning Act 2008 ("PA 2008") for a Development Consent Order ("DCO"). If made the DCO would grant consent for the Applicant to undertake the A47 North Tuddenham to Easton ("the Scheme"). A detailed description of the Scheme can be found in the Environmental Statement Chapter 2 The Proposed Scheme (APP-041).
- 1.1.2 This Statement has been prepared to provide the Examining Authority ("ExA") with the current position on Statements of Common Ground ("SoCG") between Highways England and prescribed consultees, statutory undertakers and interested parties ("other parties") in relation to the Scheme.
- 1.1.3 This Statement also provides a current position on the commonality on specific points in the various SoCGs at Examination Deadline 1 (01 September 2021).
- 1.1.4 This Statement will be updated and submitted at subsequent Examination Deadlines as necessary.



#### 2 STRUCTURE OF STATEMENTS OF COMMON GROUND

- 2.1.1 To ensure consistency in the approach taken to documenting matters agreed, matters subject to further negotiation or matters not agreed, each of the SoCGs adopts a standard format in order to provide clarity to other parties and ultimately the ExA.
- 2.1.2 Each SoCG has the following structure:
  - Section 1: provides an introduction to the SoCG and a description of its purpose.
  - Section 2: states the engagement that has occurred between the Applicant and the relevant party.
  - Section 3: sets out any issues that have arisen, reporting on the status of each issue, i.e. whether it is agreed, still under discussion or not agreed, and any remaining actions.
  - Appendices which contain any relevant document not forming part of the application that are referenced in the SoCG (e.g. emails / meeting notes / data).



#### 3 LIST OF STATEMENTS OF COMMON GROUND

- 3.1.1 The Applicant has begun to prepare SoCGs with a number of prescribed consultees, statutory undertakers and other parties it considered beneficial to do so following acceptance to Examination.
- 3.1.2 SoCGs with further specific parties were also requested by the ExA through the Rule 6 letter dated 27 April 2021 and the Rule 8 letter dated 12 August 2021.
- 3.1.3 The parties which the Applicant is exploring the possible need for SoCGs are listed in Table 3-1 below. Further detail about the current position of each SoCG can be found at Section 4, Table 4-1 of this Statement.

#### 4 SUMMARY OF CURRENT POSITION

- 4.1.1 This section provides the current position of each SoCG as at Deadline 1. As final versions of the SoCGs are agreed as the DCO Examination progresses, they will be submitted alongside this Statement.
- 4.1.2 Table 4-1 provides a high-level position and where necessary includes further detail to aid understanding of the ExA. The high-level positions used in the table are:
  - Final Signed SoCG all matters agreed The final SoCG has been signed by both parties and all matters are agreed.
  - Final Signed SoCG with matters outstanding The final SoCG has been signed by both parties, and there remain matters outstanding, that the Applicant and the other party agree, will not be resolved during the Examination.
  - Draft SoCG The SoCG has been drafted by the Applicant, it has been shared with the other party and comments have been provided. Discussion is ongoing to reach a 'Final Signed SoCG all matters agreed' or 'Final Signed SoCG with matters outstanding'.
  - SoCG drafted and shared with other party The SoCG has been drafted by the Applicant and shared with the other party, but awaiting comments to be provided before issue as 'SoCG in draft' to the Examining Authority. The SoCG will be provided at the earliest opportunity.
  - SoCG under preparation The SoCG to be drafted by the Applicant subject to on-going discussions with the other party. The SoCG or position statement on why SoCG not needed will be provided at the earliest opportunity.





#### 6 POSITION AT DEADLINE 1

#### 6.1 Introduction

- 6.1.1 This section provides the ExA with a summary of the current position at Deadline 1 between the Applicant and each party. The individual SoCG should be referred to for the full detail on specific matters.
- 6.1.2 For the statutory undertakers in Section 6.4, the Applicant and the parties are focusing on is seeking agreement of the Protective Provisions and/or (where relevant) a side agreement, unless it is agreed with the statutory undertaker that a SoCG is required.

# 6.2 Statutory Environmental Bodies

#### **Natural England**

- 6.2.1 The position of Natural England at Deadline 1 is currently Under Discussion.
- 6.2.2 A draft SoCG is being developed between the Applicant and Natural England. The draft reflects the issues raised during statutory consultation and meetings/correspondence on the development of the Scheme design and Environmental Statement. The Applicant is awaiting comments from Natural England on the SoCG, but notes that Natural England have not submitted a Relevant Representation. The Applicant and Natural England will continue discussions and aim to reach agreement on any outstanding points.

#### **Environment Agency**

- 6.2.3 The position of Environment Agency at Deadline 1 is currently Under Discussion.
- 6.2.4 A draft SoCG is being developed between the Applicant and the Environment Agency. The draft reflects the issues raised: during statutory consultation; during meetings/correspondence on the development of the Scheme design and Environmental Statement; following receipt of the Relevant Representations; and during discussions on issues during August 2021. The Applicant will continue to engage with the Environment Agency to gain agreement on these and any further matters.

#### **Historic England**

6.2.5 The position of Historic England at Deadline 1 is that all current issues have been agreed and a signed SoCG has been submitted at Deadline 1.

#### 6.3 Local Authorities

#### **Norfolk County Council**

- 6.3.1 The position of Norfolk County Council (NCC) at Deadline 1 is currently Under Discussion.
- 6.3.2 A draft of the SoCG is being developed between the Applicant and NCC. The draft reflects the issues raised: during statutory consultation; during



- meetings/correspondence on the development of Scheme design and Environmental Statement; following receipt of the Relevant Representations; and during discussions on issues during August 2021.
- 6.3.3 The SoCG is also being designed to distinguish between issues relevant to NCC as a Local Authority and its separate role as the Norwich Western Link developer.
- 6.3.4 The Applicant will continue to engage with NCC to gain agreement on these and any further matters.

#### **Breckland Council**

- 6.3.5 The position of Breckland Council at Deadline 1 is currently Under Discussion.
- 6.3.6 A draft SoCG between the Applicant and Breckland Council is included within DCO application in Section 3.1 of Consultation Report Annex M: Engagement with Stakeholders (APP-037).
- 6.3.7 A draft of the updated SoCG is being developed between the Applicant and Breckland Council to reflect Relevant Representations from Breckland Council and the Applicant's responses to these.
- 6.3.8 The Applicant will continue to engage with Breckland Council to gain agreement on the Relevant Representations and any further matters that arise.

#### **Broadland District Council**

- 6.3.9 The position of Broadland District Council ("BDC") at Deadline 1 is currently Under Discussion.
- 6.3.10 A draft SoCG between the Applicant and BDC is included within DCO application in Section 3.2 of Consultation Report Annex M: Engagement with Stakeholders (APP-037).
- 6.3.11 A draft of the updated SoCG is being developed between the Applicant and Broadland District Council to reflect Relevant Representations from Breckland Council and the Applicant's responses to these.
- 6.3.12 The Applicant will continue to engage with BDC to gain agreement on the Relevant Representations and any further matters that arise.

#### South Norfolk Council

- 6.3.13 The position of South Norfolk Council (SNC) at Deadline 1 is currently Under Discussion.
- 6.3.14 A draft SoCG between the Applicant and SNC is included within DCO application in Section 3.3 of Consultation Report Annex M: Engagement with Stakeholders (APP-037).
- 6.3.15 A draft of the updated SoCG is being developed between the Applicant and SNC to reflect Relevant Representations from Breckland Council and the Applicant's responses to these.
- 6.3.16 The Applicant will continue to engage with SNC to gain agreement on the Relevant Representations and any further matters that arise.



## 6.4 Prescribed Bodies – Statutory Undertakers

#### **Anglian Water Services Ltd**

6.4.1 The position of Anglian Water at Deadline 1 is currently Under Discussion. Discussions are ongoing and focussed on protective provisions, and the Applicant expects to be in a position to respond to Anglian Water later this week. Anglian Water are considering whether a SoCG is appropriate.

#### **BT Openreach Ltd**

6.4.2 BT Openreach Ltd have confirmed that the standard protective provisions included within the draft DCO, at Part 2, Schedule 9 (APP-017) provide adequate protections for their interests and therefore do not intend to take part in the examination process. The Applicant therefore does not intend to enter into a SoCG with BT Openreach Ltd.

#### **National Grid Gas Ltd**

The position of National Grid Gas Ltd at Deadline 1 is currently Under Discussion. Discussions are ongoing and focussed on protective provisions and a side agreement between the Applicant and National Grid Gas Ltd. Discussions are ongoing in relation to the development of the design and construction methodology for diverting the high pressure gas pipeline in advance of the main works. If issues are raised by National Grid Gas Ltd with the Scheme, the Applicant will discuss entering into a SoCG with National Grid Gas Ltd.

## **UK Power Network (UKPN)**

6.4.4 UKPN has been made aware of the Scheme. The Applicant has been meeting regularly with UKPN and there have been no issues raised to date. UKPN has not submitted any Relevant Representations and in any event UKPN can rely on the standard protective provisions included within the draft DCO, at Part 2, Schedule 9 (APP-017). If issues are raised by UKPN with the Scheme, the Applicant will discuss entering into a SoCG with UKPN.

#### **Vodafone LTD**

No Vodafone assets are directly affected, but the Applicant is engaging with Vodafone about maintaining access to two mobile phone masts. The position at Deadline 1 is currently Under Discussion. Vodafone are considering whether a SoCG is appropriate and are reviewing the protective provisions contained in Part 2, Schedule 9 of the draft DCO.

## Hornsea Project Three (UK) Ltd

- 6.4.6 The Applicant is engaging with Orsted's Hornsea Project Three Ltd about the interaction of their respective DCO schemes. The position at Deadline 1 is currently Under Discussion.
- 6.4.7 Following the submission of Hornsea Project Three Ltd's relevant representation, both Parties have continued to work together to agree a draft SoCG and hope to submit a draft SoCG by Deadline 3 (05 October 2021).
- 6.4.8 The Parties also continue to discuss protective provisions, but hope that a co-



operation agreement to facilitate co-existence will be entered into to dispense with the need for protective provisions. The Parties will keep the Examiner updated as to the progress of the co-operation agreement and if sufficient progress is not made then draft protective provisions will be submitted by Deadline 4 (12 November 2021).

#### **Vattenfall**

- 6.4.9 The Applicant is engaging with Vattenfall about the interaction of their respective DCO schemes. The Vattenfall scheme is not directly affected, so construction traffic management is the only issue of common concern.
- 6.4.10 The Applicant has already agreed a SoCG with regards Vattenfall's Norfolk Vanguard Ltd DCO application<sup>1</sup>. The position at Deadline 1 is currently Under Discussion, including whether a separate SoCG is required to clarify existing references to managing traffic along the A47.

#### 6.5 Other Interested Parties

#### **Berry Hall Estate**

- 6.5.1 The position with Berry Hall estate at Deadline 1 is currently Under Discussion.
- 6.5.2 The Applicant is currently engaging with Berry Hall Estate representatives to explore issues of concern that are dependent on the outcome of a review of an alternative Wood Lane junction design to be presented by the Berry Hall Estate.
- 6.5.3 The Applicant has responded to issues raised in the Berry Hall Estate's Relevant Representations as part of the Deadline 1 submission.
- 6.5.4 A SoCG will be produced once the Applicant has considered the proposed alternative design, still to be received at Deadline 1, and confirmed the scope of the concerns to be agreed or not agreed.
