## 1 INTRODUCTION

- 1.1.1 This document has been prepared in response to the letter from the Planning Inspectorate titled Planning Act 2008 – Section 89 and The Infrastructure Planning (Examination Procedure) Rules 2010 – Rule 8 etc (the “Rule 8 letter”) dated 12 August 2021.
- 1.1.2 The Examining Authority (ExA) has requested an Accompanied Site Inspection (ASI) during the week commencing 15 November 2021.
- 1.1.3 Annex A to the Rule 8 letter sets out the Examination Timetable for the Development Consent Order (DCO) application by the Examining Authority (ExA). Item 7 states that at Deadline 1 (D1) the Applicant should submit a draft ASI itinerary.
- 1.1.4 This [draft-revised](#) itinerary has been prepared in response to these requirements and has taken into consideration the Examining Authority’s Unaccompanied Site Inspection (USI) note (**EV-001**)<sup>1</sup>. Annex A to this document presents a copy of the ExA’s report of their USIs in July 2021.
- 1.1.5 As per Item 7 in Annex A of the Rule 8 letter, the draft itinerary ~~is to be~~ [allowed](#) all parties to comment on the draft itinerary and propose additional locations, with supporting justification, by Deadline 2 (14 September 2021). [Annex B contains the ExA’s review of comments on the draft ASI received from Anthony Meynell, Weston Longville Parish Council, Richard Hawker and Mark Kenney. This](#) revised itinerary ~~has been will be~~ submitted by the Applicant at Deadline 3 (5 October 2021) [in response to this feedback review](#).

## 2 PROPOSED ACCOMPANIED SITE INSPECTION ITINERARY

### 2.1 Introduction

- 2.1.1 The Examining Authority’s inspection of sites is an opportunity for the ExA to look at physical features that can be seen on, or from the sites. Participants may be invited by the ExA to point out specific features or sites of interest. It is not an opportunity to provide any oral representations on the project or discuss evidence.
- 2.1.2 Owing to limited daylight hours, the itinerary has focused on those locations only accessible across private land and/or the focus of concerns raised by the Relevant Representations or during the Preliminary Meeting and Oral Hearing in August 2021.
- 2.1.3 The proposed itinerary is presented in Table 2.1 while the proposed ~~route has been~~ [stops are](#) illustrated in Figure 2.1.

## 2.2 Advising of Wish to Join the Site Visit

2.2.1 As per Item 5 in Annex B of the Rule 8 letter, ~~the deadline for~~ Interested Parties ~~to should~~ confirm their wish to attend the ASI to the Planning Inspectorate's Case Team ~~14 September 2021 by~~ (Procedural Deadline D-~~14 September 2021~~). ~~Submissions should be made as per the instructions in Annex E of the Rule 8 letter.~~ The Rule 8 letter is available on-line at:

2.2.2 It may be necessary to limit the numbers of persons who accompany the ExA for logistical and safety reasons, but it should be possible for arrangements to be made for Interested Parties (or their representatives) to join the inspection at specified locations within the itinerary. Please notify the Planning Inspectorate Case Team if you wish to be considered for joining for the whole day or meet the inspection at a specific location within the itinerary, or at a new location, as proposed in your comments. Those joining for the whole day are referred to hereafter as the Core Team.

2.2.3 The final itinerary for the ASI will be published on the project page of the National Infrastructure Planning website at least a week before the ASI. Interested Parties should be aware that ASIs are not an opportunity to make any oral representations to the ExA about the Proposed Development. However, the ExA may invite participants to indicate specific features or sites of interest.

2.2.4 To ensure the smooth running of the ExA's inspection, it is requested that Interested Parties wishing to attend the site visit:

- provide a contact mobile number to the Planning Inspectorate's Case Team for the day,
- notify the Planning Inspectorate's Case Team if there are any changes in attendance, and
- ensure the Planning Inspectorate's Case Team is made aware of any special access requirements for any participants.

## 2.3 Joining the Site Visit on the Day

2.3.1 For those joining the Core Team, these participants ~~will start the visit from~~ ~~LOCATION NAME AND ADDRESS TBC. All Core Team participants~~ are asked to arrive and report to the Applicant no later than ~~08:00~~ ~~7:53~~ ~~am~~ ~~am~~. This is to allow for a Health and Safety briefing and allocation of people to vehicles to be given to participants prior to departure. The Applicant will be at the venue by 7:53am to welcome participants.

2.3.2 The Health and Safety briefing will start promptly at 08:007:45am. We are not able to wait or delay the briefing so as to enable the site visit to start promptly with the departure of vehicles from the venue at 08:15am; any parties who are not present at the requested time or arrive late cannot be accommodated. Transportation for the ASI will be provided on a first-come, first-served basis.

2.3.3 It is not possible to predict precisely how long each part of the inspection will last. For those Interested Parties wishing to join at an alternative location, the Applicant will use their mobile contact number to keep those Interested Parties notified of progress and expected arrival times where they are due to meet.

## 2.4 Transport Arrangements

2.4.1 The Applicant will confirm transport arrangements depending on the number of attendees, current COVID restrictions and availability of parking places at the stops. Where necessary, the Applicant will provide a vehicle(s) for the site visit ~~which will take place around the A47, B roads and local roads.~~ This approach has been proposed to minimise transport emissions and disruption along the local road network and around the limited locations for parking.

2.4.2 The se vehicle(s) will be used to convey those attending the visit for the whole day, from start to finish, as a member of the Core Team. Interested Parties planning to join for part of the visit along the route will be expected to arrange their own mode of transport, but have regard to the itinerary timings, locations and parking arrangements with the Planning Inspectorate's Case Manager in advance; see Section 2.3 above.

## 2.5 Safety Instructions

2.5.1 Some of the locations will be observed on foot, possibly on uneven, wet or frozen ground and accessed via local roads with narrow or no footway provision. There will be limited daylight hours at this time of the year and visibility will be reduced towards the end of the day. A safety briefing will be provided to the Core Team at the beginning of the day. For those Interested Parties joining along the route for part of the visit, they will be sent the briefing pack ~~in advance~~ to read in advance and requested to sign an acknowledgement ~~in writing prior to when joining~~ the site visit.

2.5.2 High visibility vests will be provided for attendees and must be worn at all times when out of the vehicle. When stopping on a live road, a mini-briefing will be provided before attendees exit the vehicle, which will include where to stand and how to remain safe. All attendees:

- Must follow instructions given to them by the Health and Safety staff representative from GallifordTry and provided by the risk assessment.
- Are responsible for their own safety and must never act in a manner that might reduce the safety of themselves or others.

2.5.3 With regards COVID, the appropriate controls in accordance with the latest Government guidelines at the time of the site visit will be applied and managed through the risk assessments and safety briefings.

## 2.6 Clothing

- 2.6.1 It will be necessary for all parties to wear appropriate sturdy footwear and weather-proof clothing appropriate for the time of the year. All parties are advised to bring their own high visibility jackets, if they have them, but the Applicant will provide high visibility vests for all attendees to wear.

## 2.7 Sites on Private Land

- 2.7.1 The Applicant will arrange visits to private land, however access onto private land is at all times by the permission of the person controlling it; householders, occupiers and landowners may refuse to allow some persons accompanying the ExA onto their land. Under those circumstances, the ExA will decide whether or not to proceed with that part of the inspection and may ask those refused access to wait outside.

## 2.8 Refreshments and Welfare Facilities

- 2.8.1 ~~Please note refreshments and lunch will not be provided.~~ A lunch break has been included in the itinerary and ~~attendees should bring their own lunch with them.~~ However, we will arrange for stops along the route to access to welfare facilities. Lunch arrangements for the Core Team will be confirmed prior to the site visit.

## 2.9 Cancellations

## 2.10 Detailed Itinerary for Accompanied Site Inspection

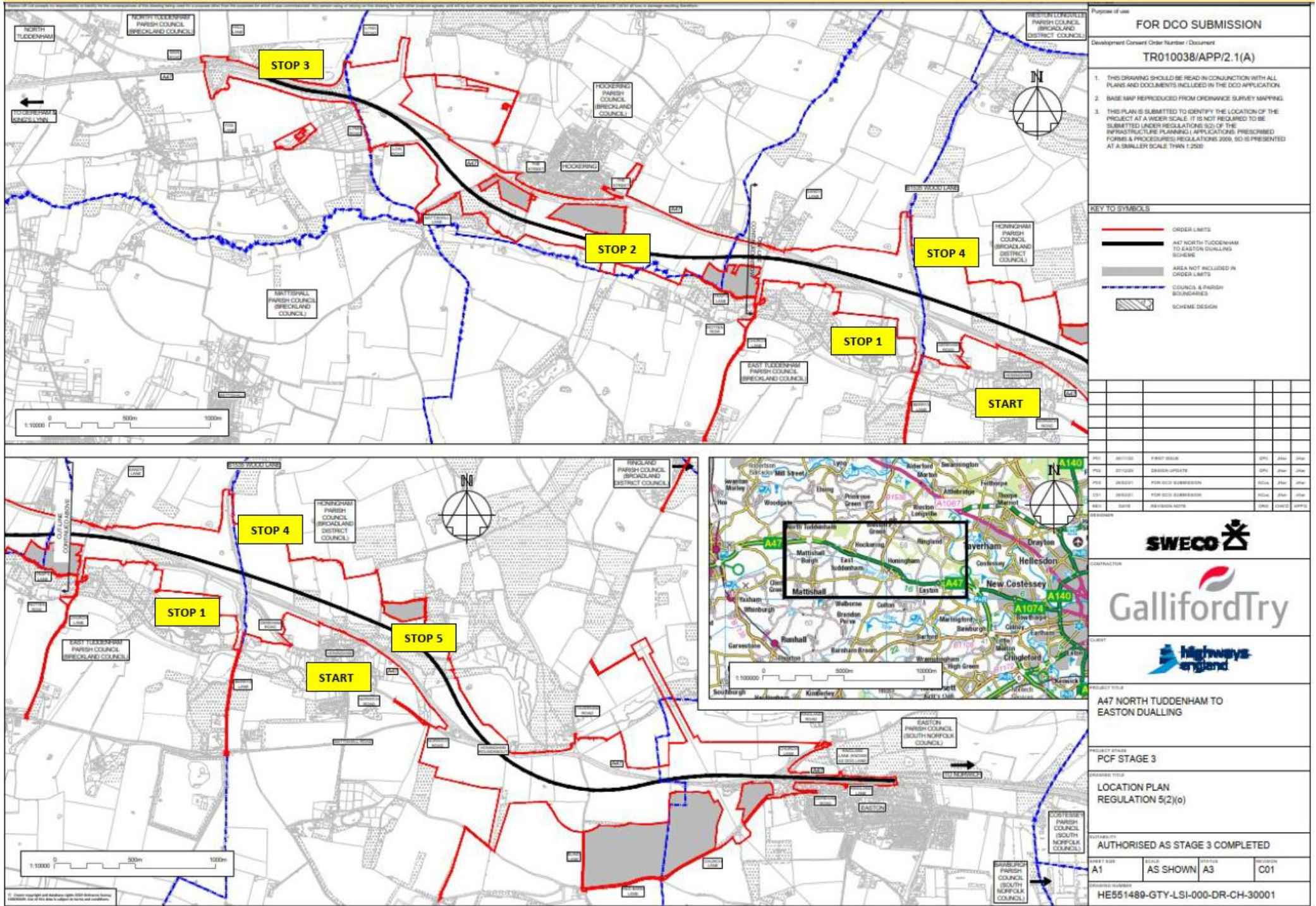

## **ANNEX A – EXAMINING AUTHORITY’S JULY 2021 UNACCOMPANIED SITE INSPECTION NOTES**

### **The Planning Act 2008**

Application for Development Consent for the A47 North Tuddenham to Easton project.  
Case Ref: TR010038

### **Examining Authority’s Record of Unaccompanied Inspection of Sites to which the Application Relates (USI1).**

The Examining Authority (ExA) undertook an Unaccompanied Site Inspection (USI1) on 12 and 13 July 2021. The purpose of the Inspections was for the ExA to become familiar with the proposed route and look at specific locations particularly in relation to general surrounds, heritage, noise, visual and landscape considerations.

Inspections were undertaken by car and on foot from publicly accessible land including highways and public rights of way. No inspections were undertaken on private land and therefore advance permission to enter land was not required. This allowed the inspections to be undertaken on an unaccompanied basis.

The purpose of this note is to inform the Applicant and Interested Parties (IPs) of actions already taken by the ExA and to enable the Applicant and IPs to consider which, if any, additional sites the ExA might need to inspect.

Arrangements for any Accompanied Site Inspections (ASIs) will be advised in due course. In addition, further USIs may be carried out by the ExA as required to inform them and without notice. However, if further USIs are carried out, further Inspection notes will be published.

The inspections were undertaken to view the proposed application site as shown on the Location Plan [APP-004], General Arrangement Plans [APP-005], Land Plans [APP-006], Works Plans [APP-007] and Rights of Way and Access Plans [APP-008] submitted with the application.

### **Particulars of the Inspection**

USI1 was undertaken by the Examining Inspector Mr Adrian Hunter. No other persons were in attendance.

#### 12 July 2021

The USI on Monday 12 July 2021 was undertaken during the late afternoon/early evening, to gain an appreciation and understanding of the application site and the Proposed Development; an indication of existing traffic levels; an appreciation of existing lighting arrangements; and an understanding of the relationship of the Proposed Development with other parts of the highway network.

#### 13 July 2021

The USI on Tuesday 13 July 2021 involved visiting a number of specific locations to gain an appreciation and understanding of the context of the application site, the route of the Proposed Development, its surroundings, and views of it.

The ExA also drove along the A47 and along a number of local roads in the vicinity

of the application site. He noted the nature of the roads and the character of the surroundings. Locations visited, both by vehicle and on foot, included:

- Dereham Road, Easton;
- Blind Lane;
- Norwich Road, Honingham;
- Mattishall Road, Honingham;
- Dereham Road, Honingham;
- Berrys Lane;
- Church Lane;
- Mattishall Lane, Hockering;
- Low Road, Hockering;
- Sandy Lane;
- Wood Lane; and
- Taverham Road.

The ExA also observed views towards the application site from the vicinity of a number of designated heritage assets. This was to gain an appreciation of these heritage assets and their setting. The heritage assets included:

- St Peter's Church, Easton;
- St Andrew's Church, Honingham;
- St Michael's Church, Hockering;
- Church Farm House and Barn at Church Farm, Taverham Road; and
- Berry Hall, Berrys Lane.
