The A47 North Tuddenham to Easton Development Consent (Correction) Order 2023

Coming into force 11th October 2023

The A47 North Tuddenham to Easton Development Consent Order 2022 ("the 2022 Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contained correctable errors as defined in paragraph 1(3) of Schedule 4 to the Act.

Citation and commencement

1. This Order may be cited as the A47 North Tuddenham to Easton Development Consent (Correction) Order 2023 and comes into force on 11th October 2023.
