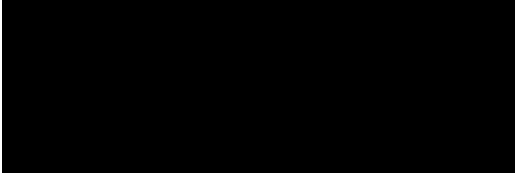
PROPOSED AMENDMENT TO THE SCHEME
