Planning Act 2008 (as amended) and the Infrastructure Planning (Examination Procedure) Rules 2010

Application by National Highways Limited ("the Applicant") for an Order granting Development Consent for the provision of the proposed A47 Blofield to North Burlingham Project ("the Proposed Development") to provide additional road capacity through the de-trunking of an existing single lane section of the A47 between Blofield and North Burlingham, and its replacement with a new section of dual carriageway to tie in with the existing A47.

# REQUEST FOR COMMENTS FROM THE APPLICANT AND NORFOLK COUNTY COUNCIL ("NCC")

The Examining Authority submitted on 22 March 2022 a Report and Recommendation in respect of its findings and conclusions on the above application to the Secretary of State for Transport ("the Secretary of State"). In accordance with section 107 of the Planning Act 2008, the Secretary of State has until 22 June 2022 to make a decision on the application. The Secretary of State invites comments in relation to the following matters which were outstanding at the end of the Examination

### **NCC** protective provisions

The Secretary of State notes as of 18 March 2022, no agreement had been reached between the applicant and NCC on matters relating to the future maintenance of assets to be transferred to NCC upon the satisfactory completion of the Proposed Development.

NCC have provided the attached protected provisions and have asked that they be included in the DCO if no agreement is reached. Please could the **Applicant** and **NCC** confirm the status of the agreement mentioned above?



If agreement had not been reached, please could the **Applicant** comment on (i) NCC's request that the protective provisions be included in the DCO, (ii) the protective provisions themselves.

#### **Land Plans**

Please could the **Applicant** provide an amended version of the Land Plans. Plot 4/7c is annotated on Inset G on Sheet 4 of the Land Plans [REP4-002]. This is an error (as Plot 4/7c is correctly shown elsewhere on Sheet 4) which the Inspector requested the Applicant correct. Whilst the Applicant indicated it had done so (Ref 3.2 on page 33 of [REP4-051]), this does not appear to be the case.

## **Badger Survey Report**

Please could the **Applicant** confirm how they propose to secure the recommendation included in the Badger Survey Report (which has not been published as it is confidential) at paragraph 5.1.3.
