Having spoken to some other Interested Parties today, we as a company now feel it is an absolute must that we have a SoCG since the following have come out of the discussions.

Opening Regimes for all 3 bridges are not being taken as a complete package by the Applicant as the Applicant feels they only need to consider the 3rd Bridge crossing openings on its own merit. If this is the case, then we strongly disagree with it being recommended to being constructed.

SoCG from the Broads Authority Having read with interest their SoCG when publish on your site on the 10th October, we thought this would cover our concerns as a commercial entity it **does not**. The Navigation Committee and the Broads Authority appears to not appreciate that the Project has moved on and perhaps they will not get another opportunity to express their views. I see that their SoCG is complete and submitted so that seems to be end of discussions with the Broads Authority.

We are trying to be proactive before it is too late to have our views heard.

There is absolutely no mention of a commercial facility being within the Broads network and our concerns have not been covered.
