The updates to the Examination Timetable are summarised as follows:

- New **Deadline 5a** for the Applicant to submit its report dealing with consultation on the proposed changes to the application and for any additional representations to be made by Interested Parties on the requested changes.
- New items inserted under **Deadline 6** for Interested Parties to make representations to the ExA on the above report and for the Applicant to respond to any representations made at Deadline 5a.
- Date inserted upon which the ExA will issue a Procedural Decision in respect of the proposed changes to the application – 25 February 2020.
- New item inserted under **Deadline 7** for the Applicant to submit amended Application documentation incorporating the requested changes into the Scheme (if accepted). The deadline date has also been moved to accommodate the Procedural Decision above.

In addition, this letter clarifies that, having considered the evidence, I no longer consider that the hearings originally reserved for January 2020 are required and they have now been removed from the Examination Timetable. The new Deadline 5a will allow any Interested Party to submit additional comments on the requested changes in lieu of discussion at a hearing.
