2.0.2	GYBC/NCC	The latest iteration of the dDCO (REP4-006 - Schedule 2 Requirements Part 2, Paragraphs 20 and 21) includes an increase in the determination period from 6 to 8 weeks for the discharge of certain details. Can the Council confirm whether it is satisfied with this amendment?	Following the Issue Specific Hearing on the draft Development Consent Order (dDCO) held on the 20 November 2019, further discussions have taken place with the applicant. An agreement has been reached to increase the determination period for the discharge of requirements to 8 weeks, and to increase the period of time which the CPA can request further information relating to the details required for approval to 28 days as set out in the dDCO (document reference NCC/GY3RC/EX/049 dated, 11 December 2019. PINS reference REP4- 006). In addition, the CPA welcomes the applicant's commitment to carryout pre-consultation prior to the submission of details required for	



		approval under the Requirements as set out in Requirement 18 of the dDCO.
