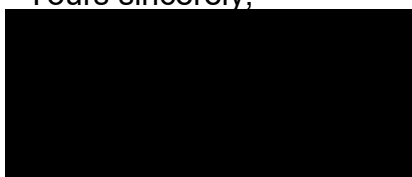

In order to avoid replicating some SI template formatting issues which had arisen in the Examining Authority's draft DCO, we have used the Applicant's draft DCO Revision 5 as the base document for the Applicant's updated draft DCO (Revision 6) being submitted at Deadline 9. The updated draft DCO (Revision 6) includes the new drafting in Requirement 10 in Schedule 2, as previously proposed by the Applicant in its Response to the Examining Authority's Request for Further Information (Rule 17) submitted at Deadline 8 (Document Reference NCC/GY3RC/EX/088; Planning Inspectorate Reference REP8-002).
