# 1 Introduction

## 1.1 Purpose of this document

- 1.1.1 This document provides a guide to the Applicant's Development Consent Order application for Great Yarmouth Third River Crossing.
- 1.1.2 The application was submitted to the Planning Inspectorate on 30 April 2019 and accepted for examination on 28 May 2019.
- 1.1.3 Subsequent to the initial submission some of these documents will be updated and further documents will be produced in response to requests by the Examining Authority.
- 1.1.4 This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline, in accordance with the Examining Authority's Procedural Decision set out in item 6 of Annex F to the Rule 6 letter (issued pursuant to Rule 6 of the Infrastructure Planning (Examination Procedure) Rules 2010 (as amended) and section 88 of the Planning Act 2008).
