DRAFT MITIGATION LICENCE APPLICATION STATUS: SUBSEQUENT DRAFT APPLICATION LEGISLATION: THE WILDLIFE AND COUNTRYSIDE ACT 1992 (as amended) NSIP: Great Yarmouth Third River Crossing, William Adams Way, Great Yarmouth, Norfolk, NR1 SPECIES: Water vole.

Thank you for your subsequent draft water vole mitigation licence application in association with the above NSIP site, received in this office on the 15 May 2020. As stated in our published guidance, once Natural England is content that the draft licence application is of the required standard, we will issue a 'letter of no impediment'. This is designed to provide the Planning Inspectorate and the Secretary of State with confidence that the competent licensing authority sees no impediment to issuing a licence in future, based on information assessed to date in respect of these proposals.

Assessment

Following our assessment of the resubmitted draft application documents, I can now confirm that, on the basis of the information and proposals provided, Natural England sees no impediment to a licence being issued, should the DCO be granted.

However, please note the following issues have been identified within the current draft of the method statement that will need to be addressed before the licence application is formally submitted. Our wildlife adviser, Sonya Gray, discussed this matter with Katie Rowberry via telephone and e-mail correspondence on the 8 June 2020 and 11 June where it was confirmed that the necessary amendments would be made. Please do ensure that the Method Statement is revised to include these changes prior to formal submission. For clarity these include:

Section 1 - Confirmation that the named ecologist has visited the site.

Section 2 - Results of updated surveys to be carried out in 2020, one between mid-April and end of June, one between July and September.

3.1.2 – To be updated to specify the length of WC1 to be permanently lost and temporarily lost and length WC4 to be temporarily lost.

4.1.1 Details of habitat loss recorded in this section of the method statement should be moved to section 3.

An Illustration of the water vole exclusion fencing should be provided.

4.5.7 The following amendments to the Displacement methodology are required:

- Vegetation must be cleared down to bare earth
- There must be a minimum of a 3 metre buffer either side of both areas where displacement will occur.
- Details of the waterdraw down methodology should be provided.
- If water voles still present when the cleared sections are re-surveyed and destructive search must not commence. Further checks should be made to ensure vegetation is completely clear and monitoring. If evidence of water vole presence remains, trapping may need to be considered
- The destructive search must be supervised by an ecologist and must only take place once there is <u>no</u> evidence of water voles.
- Details of what will occur if water voles are found during destructive search should be included

Consideration should also be given to the merits of undertaking relocation by trapping, rather than displacement, on WC1 as this should enable more of the northern habitat to be retained. Alternatively, if displacement is carried out, consideration should be given to not undertaking a destructive search of burrows.

5.1.1. Table 4 - To be updated to include length of WC1 and WC4 to be reinstated.

5.1.4 – Details of the management measure of the existing vegetation in watercourse should be provided.

5.1.5 – Details of design of the culverts , as recorded in section 3.1.5 should be recorded here. Details of mammal ledge design should also be included.

Compensation measures should be illustrated on a post development plan of the site.

Next Steps

Should the DCO be granted then the mitigation licence application must be formally submitted to Natural England. At this stage any modifications to the timings of the proposed works, e.g. due to ecological requirements of the species concerned, must be made and agreed with Natural England before a licence is granted. Please note that there will be no charge for the formal licence application determination, should the DCO be granted, or the granting of any licence.

If other minor changes to the application are subsequently necessary, e.g. amendments to the work schedule/s then these should be outlined in a covering letter and must be reflected in the formal submission of the licence application. These changes must be agreed by Natural England before a licence can be granted. If changes are made to proposals or timings which do not enable us to meet reach a 'satisfied' decision, we will issue correspondence outlining why the proposals are not acceptable and what further information is required. These issues will need to be addressed before any licence can be granted.
