Purpose and content of the letter

1. The Examination Timetable

The ExA has made a Procedural Decision about the way the application will be examined and published the final Examination Timetable, attached in **Annex A**. The Examination Timetable replaces the draft timetable that was included in the Rule 6 letter dated 9 July 2021. In finalising the Examination Timetable, we have sought to accommodate requests and suggestions made at the Preliminary Meeting and in representations submitted in advance of that meeting. A brief summary of our considerations in finalising the Examination Timetable is in **Annex A**.

Please note that the Examination Timetable contains a number of Deadlines for receipt of submissions to the Examination. All Deadlines are at 23:59 on the specified date. Please ensure submissions arrive on the specified date; if your submissions are later than the dates specified in the timetable, we may not accept them into Examination.

If we consider it necessary to vary the Examination Timetable, notification will be sent to all parties invited to the Preliminary Meeting. The changes will be published on the <u>project page of the National Infrastructure Planning website (NI website)</u>.

2. Making your submissions

We request that all parties make their submissions through the project page of the NI website), where you will find a 'Make a submission' tab which provides access to a submissions portal ahead of the relevant Examination Deadlines. Electronic attachments should be clearly labelled with the subject title and not exceed 12MB. **Providing links to websites where your submissions can be viewed is not acceptable.**





All submissions must be made in a format that can be viewed in full on the NI website. Any submissions that exceed 1500 words should be accompanied by a summary which should not exceed 10% of the original text. **Annex E** provides further information on submissions via the portal

3. ExA's First Written Questions

The ExA provided all parties advance access to the intended list of the ExA's First Written Questions and requests for information (WQ1) on Wednesday 21 July 2021, in order to facilitate the conduct of the Examination. WQ1 is now being issued formally alongside this Rule 8 letter; WQ1 are published on the project page of the NI website and can be accessed through this link:

While there are no amendments to the questions in the formal issue of WQ1, we have issued some additional questions in light of the matters raised at the Preliminary Meeting, Issue Specific Hearing 1 and the Open Floors Hearing 1. These additional questions are clearly marked. Responses to WQ1 are due by **Deadline 1, Tuesday 31 August 2021.** Please see the Examination Timetable (**Annex A**).

If you require a hard copy of our WQs, please contact the Case Team who will send you a copy.

4. Written Representations

In the Rule 6 letter dated Friday 9 July 2021, the ExA provided notice to all parties to submit Written Representations by **Deadline 1, Tuesday 31 August 2021.** Please see the Examination Timetable (**Annex A**). We reiterate that the Deadline and date for receipt of Written Representations stands.

Many of you may have already submitted Relevant Representations in line with Rule 3 of The Infrastructure Planning (Examination Procedure) Rules 2010, which is the first round of representations received by the ExA. In line with Rule 10 of The Infrastructure Planning (Examination Procedure) Rules 2010, any person, other than the Applicant, who submits a Written Representation must identify those parts of the application with which they agree and those parts with which they do not agree, explaining the reasons why. Interested Parties should also provide with their Written Representations the data, methodology and assumptions used to support their submissions.

Written Representations can cover any relevant matter and are not restricted to the matters set out in our Initial Assessment of Principal Issues discussed at the Preliminary Meeting and included in our Rule 6 letter. Nor are they restricted to the content of ExA's First Written Questions. Further written submissions will be requested by the ExA at various points in the Examination.





Any Written Representations, and any further written submissions requested by the ExA in the course of the Examination which exceed 1500 words should also be accompanied by a summary which should not exceed 10% of the original text. The summary should set out the key facts of the written submission and must be representative of the submission made.

5. Notification of Hearings and Accompanied Site Inspection

We have made a Procedural Decision to hold the following Hearings. Important information about these hearings is contained in **Annex B**.

- Virtual Compulsory Acquisition Hearing (CAH1) on Wednesday 22 September 2021
- 2. Virtual Issue Specific Hearing (ISH2) on Thursday 23 September 2021
- 3. Virtual Issue Specific Hearing (ISH3) on Friday 24 September 2021

We have reserved a date to hold a further hearing, if required:

4. Virtual Issue Specific Hearing or Compulsory Acquisition Hearing on Tuesday 28 September 2021.

Participation in a virtual Hearing relies on the Planning Inspectorate providing you with a joining link or telephone number in advance. If you wish to attend a Hearing, you must register by **Procedural Deadline C, Tuesday 31 August 2021.** Please see the Examination Timetable (**Annex A**).

6. Accompanied Site Inspection

An Accompanied Site Inspection (ASI) is scheduled to take place on Tuesday 21 September 2021 and this is set out in **Annex A** and **Annex B**. If you wish to attend the ASI, it is important that you register at the latest by **Procedural Deadline C**, **Tuesday 31 August 2021.** Please see the Examination Timetable (**Annex A**).

The Applicant is to submit their proposed itinerary for the ASI to the ExA by **Deadline 1, Tuesday 31 August 2021**. This should have regard to any locations proposed by other parties at Procedural Deadline A, as well as those locations favoured by the Applicant.

The ExA has visited the site during Unaccompanied Site Inspections (USI) in June and July and so has a reasonable understanding of the scheme, the site and its surrounding. We will not re-visit any location unless there are good reasons. Notwithstanding the Applicant's comments at the Preliminary Meeting Part 1, the ExA considers that the ASI can be completed in one day rather than two.

To inform the Applicant's preparation of the proposed itinerary for the ASI, the ExA has set out a long list of priorities here:





- 1. Site and immediate surrounds of the proposed Black Cat Grade Separated junction;
- 2. Black Cat Quarry;
- 3. Location of proposed high pressure pipeline diversion;
- 4. Interaction between the Proposed Development and East Coast Main Line Railway;
- 5. Top Farm buildings in Little Barford;
- 6. Potton Road junction near Eynesbury Plant Hire Company, and the proposed single overbridge nearby;
- 7. Proposed Cambridge Road Grade Separated Junction;
- 8. Yelling;
- 9. Toseland;
- 10. Proposed works, including two new roundabout junctions and a new overbridge at/ near Eltisley; and
- 11. Proposed Caxton Gibbet Grade Separated Junction.

We acknowledge that the list of sites proposed by East West Rail (EWR) Company, and sites near Eltisley proposed by the Church Commissioners of England have not been included in our list of priorities. It is recognised that the annotated maps requested by the ExA at Preliminary Meeting Part 1, were not provided by Procedural Deadline B from those parties so as to inform our priorities at this time. However, this does not mean that the Applicant should not consider them in its proposed itinerary. If it is not possible to include these sites and other in this instance, as further information about the proposed EWR scheme, and the access arrangements for the sites proposed by the Church Commissioners of England becomes available, we may consider visiting the proposed locations at a future date.

We would request the Applicant's proposed itinerary to include any of those sites listed above that are not publicly accessible. The ExA's final itinerary will be published at least one week before the ASI. We want to emphasise that there is scope within the Examination Timetable for a further ASI, where other sites could be visited, should the ExA consider this necessary.

7. Local Impact Reports

Following consideration of issues raised by various parties, both in writing and during Preliminary Meeting Part 1, the ExA has revised the Deadline for the submission of Local Impact Reports by relevant Local Authorities. Local Impact Reports are required to be submitted by **Deadline 2, Wednesday 8 September 2021**, as set out in the Examination Timetable in **Annex A**.

8. Cancellation of Open Floor Hearing 2 (OFH2)

In light of the number of parties expressing an intention to attend both Open Floor Hearings on Thursday 19 August 2021, the ExA has cancelled OFH2. The ExA made this Procedural Decisions orally at Preliminary Meeting Part 2 on Wednesday 18







August 2021, and it is subsequently being issued in writing in this Rule 8 letter. OFH1 remained unaffected and took place on Thursday 19 August 2021 at 10 am, as set out in the Rule 6 letter dated Friday 9 July 2021.

9. East West Rail Company Limited

The ExA received a representation from the East West Rail Company Limited (EWR) on 30 June 2021. This representation was received after the close of the Relevant Representation period, and as EWR do not meet any of the criteria set out in sections 102A and 102B of the Planning Act 2008, they do not have Interested Party status. Nevertheless, the Examining Authority considers EWR's contributions would be relevant to the Examination and has therefore determined that EWR's status in the Examination is that of 'other person'. While this is not defined in the Planning Act itself, there is provision in the Examination Rules and Procedures for the ExA to invite 'other persons' to participate in the Examination. Any representations made would be given weight subject to their merits and the robustness of the evidence.

10. Post Hearing Action List

The ExA has issued a Post Hearing Action List which has been published alongside this Rule 8 letter. Actions were issued at the Issue Specific Hearing 1 on Wednesday 18 August 2021. The action list is published on the <u>project page of the NI website</u>. Due date for the responses are as indicated on the action list.

11. Additional Submissions

Please note:

- 1. The Examination of the application primarily takes the form of the consideration of written submissions and oral representations made at Hearings.
- 2. The time for submission of requested documents is 23:59 on the relevant Deadline date, unless instructed otherwise by the ExA.
- 3. All information received will be published on <u>project page of the NI website</u> as soon as practicable after the Deadlines for submissions.

The ExA has sought to accommodate requests and suggestions made at the Preliminary Meeting and in representations submitted in advance of that meeting. The ExA has balanced the requests of parties with the needs of the ExA to facilitate a timely and thorough Examination. A summary of those changes are:

- The separation of Deadlines for procedural submissions and written submissions, with the inclusion of Procedural Deadlines C to E;
- To include a new Deadline 2 for the submission of Local Impact Reports;
- To reflect the cancellation of Open Floor Hearing 2; and
- Deadlines 4 and 7 (previously Deadlines 3 and 6 in Rule 6 letter) have been extended.

Any submissions that exceed 1500 words should also be accompanied by a summary; this summary should not exceed 10% of the original text.
