Application by Highways England for an Order Granting Development Consent for the A428 Black Cat to Caxton Gibbet Road Improvement Scheme

Response to matters at Deadline 4 (D4) for receipt by the Examining Authority

#### 1. Introduction

1.1. I am writing on behalf of Cambridgeshire County Council (20028267), Huntingdonshire District Council (20028273) and South Cambridgeshire District Council (20028271) (the Cambridgeshire Authorities) regarding the A428 Black Cat to Caxton Gibbet Road Improvement Scheme (the Scheme) Development Consent Order (DCO) Examination.

#### 3. Statement of Common Ground with the Applicant

- 3.1. The Councils submitted comments to the Applicant on 27 October for inclusion in an updated Statement of Common Ground (SoCG). It has been agreed that this is to be submitted by the Applicant at D4.
- 3.2. As agreed with National Highways, the Councils have not reviewed any further additions made to the SoCG by the Applicant between 27 October and 4 November.







We will do so ahead of D5, at which point a revised SoCG will be submitted to the ExA.

# 4. 9.38 Joint Position Statement with the Local Highway Authorities on Junction Modelling [REP3-024]

- 4.1. Following the publication of the Deadline 3 submissions, the Cambridgeshire Authorities note that there are two versions of the Joint Position Statement with the Local Highway Authorities on Junction Modelling before the Examining Authority. One submitted by the Applicant [REP3-024] and another submitted by Central Bedfordshire Council [REP3-043]. The version submitted by the Applicant [REP3-024] is an earlier version of the Joint Position Statement and does not include the comments submitted to the Applicant by the Cambridgeshire Authorities. In particular, it does not include the Cambridgeshire Authorities' proposal to progress the question of a common modelling methodology.
- 4.2. The Cambridgeshire Authorities wish to clarify that the version of the Joint Position Statement submitted by Central Bedfordshire Council, including the Cambridgeshire Authorities' Technical Note on Modelling [REP3-024] is the correct version for the Examination.

# 5. 9.41 Joint Position Statement with Natural England and the Local Authorities on Drainage Ponds [REP3-026]

5.1. The Cambridgeshire Authorities respectfully request the opportunity to clarify the text at 3.2 of the Cambridgeshire Authorities' Deadline 3 Cover Letter [REP3-034]. The Cambridgeshire Authorities provided comments to the Applicant at a meeting between the parties on 30 September 2021 however time did not allow for the provision of detailed comments on the text to the Applicant prior to Deadline 3. Having now reviewed the Applicant's 9.41 Joint Position Statement with Natural England and the Local Authorities on Drainage Ponds [REP3-026], the Cambridgeshire Authorities wish to clarify their position in relation to the Applicant's proposals. The Cambridgeshire Authorities' position is detailed at Appendix 1. A comparison version showing the changes between 9.41 Joint Position Statement with Natural England and the Local Authorities on Drainage Ponds [REP3-026] and the Cambrideshire Authorities' position is shown at Appendix 2.
