For faction, applicants consider whether specific surveys could be referred to in terms of the meaning of access required to adjacent land that's deadline 6/5 action, applicants confirm whether increase the notice period of 28 days in article 40 and 23 will impact the construction programme and any other part of the IES assessment if so in what way and also tied into that action is for the NFU and any other interested parties to explain with reasoning what the operational benefits would be to landowners have increased in the notice period from 14 to 28 days. That's accepting that some already have provided that information. That's deadline six. So action six updates in relation to D Trunk. And agreement to be provided in the next stick Cypress statement a common ground with Cambridgeshire Council authorities, and the timetable for agreement of the D trunking. agreement to also be provided sort of a bit clunky there. That's deadline six for the action number seven provision of the current version of the D trunking. Plan and associated side agreement, that's the applicant at deadline six action eight an update to be provided by the applicant on de trunking agreements, as well as the statement of common grounds. So this would follow it deadlines seven so we want an updated deadline six and then also an updated deadline seven and then the final action number nine clarification as to why the second version of the environmental master plan was provided and that's from the applicants ideally at the compulsory acquisition hearing, but possibly in deadlines six and that's the end of those actions.
