1 Introduction

- 1.1.1 This Guide to the Application (this Guide) is provided in relation to the A428 Black Cat to Caxton Gibbet Improvement Scheme (the Scheme). National Highways (the Applicant) has submitted an application under Section 37 of the Planning Act 2008 (the PA 2008) for an order granting development consent (a DCO) for the Scheme.
- 1.1.2 The purpose of this Guide is to help the Examining Authority (ExA) and Interested Parties understand the documents submitted as part of the application. The Guide identifies the latest version of any document that has been submitted as part of the Examination and indicates those documents which are to be certified. The Guide contains a full record of documents submitted to the Planning Inspectorate by the Applicant, including application documents that are not proposed to be certified and additional documents submitted after acceptance of the application in March 2021.
- 1.1.3 The documents identified with a 'y' in **Table 2-1** replicate those listed in Schedule 10, 'Documents to be Certified' in the draft DCO [TR010044/APP/3.1v6].

2 Application Documents Submitted

- 2.1.1 **Table 2-1** sets out all application documents submitted to the Planning Inspectorate by the Applicant. **Table 2-1** tracks the latest version of the documents, with previous superseded versions greyed out and the text struck through.
- 2.1.2 **Table 2-1** indicates those documents which are to be certified by the Secretary of State, additional application documents that are not to be certified and any new documents submitted at particular Examination deadlines. Note that all new and revised documents that relate to the application Volumes 1 to 7 are included in the relevant section in **Table 2-1**. Draft and final versions of Statements of Common Ground (SoCGs) will be submitted as part of Volume 8. All new documents that are prepared that do not relate to the application Volumes 1 to 7, or to SoCGs in Volume 8, are included in Volume 9 in **Table 2-1**.
