As Programme Leader for Highways England, I have signed the certificates.

Please note that it has been necessary to amend the certificate of compliance with Section 56. As previously notified to the Inspectorate, deposit points closed in consequence of the Covid-19 pandemic, which has meant that alternative arrangements had to be made. Posters were erected in visible locations near deposit points providing notice of the closure and details of how to obtain information electronically. Notice of the unavailability of the deposit locations was advertised in the press and notified to the required persons identified in accordance with Section 56 by letter, with the exception of parties detailed below. The notices and letters also notified persons of the extension to the relevant representations period.







Site notices under Section 56 providing information on the closure of deposit points and extension of the relevant representations period were also placed in visible locations near all six deposit points and Featherstone Community Centre.

It has also been necessary to amend the certificate due to a number of parties that should have been notified under Section 56(2)(d) of the Planning Act 2008 either not receiving a Section 56 notice or not receiving all notices relevant to them. The affected parties are detailed in the Schedule to the Certificate of Compliance with Section 56. These parties are all included in the Book of Reference [Document 4.3] submitted with the application and the updated version submitted with this letter.

The error in the issue of notices is the result of using an out of date distribution list created from a historic version of the Book of Reference. This meant that a number of additions or changes to the Book of Reference were not captured or were captured incorrectly in the distribution list used for Section 56 process. Unfortunately, the error was not identified prior to the close of the relevant representations period on 18 May 2020.

All of the above parties were issued letters explaining the error and enclosing the original Section 56 notice and a USB containing all application documents on 1 June 2020. The letters directed recipients on how to identify themselves to the Examining Authority as an interested party and to the online version of application documents. The letter states that as agreed with the Inspectorate, a form will be made available on the Inspectorate's website via the following link:

for parties to submit representations from 4 June 2020 until 23:59 on 6 July 2020. Copies of the letters sent are provided in Appendix A to this letter.

A revised spreadsheet containing details of all parties contacted during the original Section 56 process and parties contacted by 2 June 2020 is provided with this letter.

In addition to the above, and in accordance with part (b) of the Section 59 certificate of compliance, Highways England has updated the Book of Reference [Document 4.3] and attach clean and track change versions, since the application was submitted on 30 January 2020.

I am writing regarding the proposed M54 to M6 Link Road (the "Scheme"). The Scheme provides a strategic link between the M54 Junction 1 and M6 Junction 11.

Highways England is seeking development consent for the Scheme under the Planning Act 2008 (the "2008 Act").
