# THE INFRASTRUCTURE PLANNING (APPLICATIONS: PRESCRIBED FORMS AND PROCEDURE) REGULATIONS 2009

## CERTIFICATE OF COMPLIANCE WITH SECTION 56 OF THE PLANNING ACT 2008

I HEREBY certify that, in compliance with the requirements of Section 56 of the Planning Act 2008 –

- (a) notice of the accepted application was given to the required persons identified in accordance with Section 56 in March 2020 save for (i) those required persons listed in part 1 of the schedule below, who were not served with notice in error, and (ii) those required persons listed in part 2 of the schedule below, who may not have received the notice due to discrepancies with their postal address, and who were given notice of the accepted application by 2 June 2020;

Notice of the unavailability of the deposit locations was advertised in the local newspaper, national newspaper and London Gazette on 20 April 2020 and notified to the required persons identified in accordance with Section 56 by letter dated 17 April 2020.

The project is located within the administrative boundaries of South Staffordshire Council, City of Wolverhampton Council, Staffordshire County Council and Shropshire Council.

The deadline date for all representations to be received by the Planning Inspectorate under Section 56 was 18 May 2020 or, in the case of those persons listed in the schedule below, 6 July 2020.




