## M54 to M6 Link Road Scheme – Deadline 6

Please find enclosed the following documents from the Applicant for Deadline 6:

- 1.5 Guide to the Application (version P13 to supersede version P12 submitted on 20 January 2021). Clean and tracked changes versions.
- 2.2 Land Plans (version P05 to supersede version P04 submitted on 17 December 2020). The changes made are:
  - Splitting plot 4/20c into two plots by introducing a new plot 4/20d (temporary possession) with corresponding reduction in the size of plot 4/20c (permanent acquisition). This change relates to the area known as the 'Dark Lane fence'. The change reflects the agreed position between the Applicant and Allow Ltd that, instead of permanent acquisition, temporary possession of the land will taken to upgrade the boundary treatments only.
  - Splitting plot 6/17o into two plots by introducing a new plot 6/39 with a very small corresponding reduction to plot 6/17o. This new plot has been introduced because further information has been provided on the occupation of this plot and it is considered useful to distinguish the plot to clarify the area being referenced. Both plots are still proposed to be permanently acquired and there is no additional land to be acquired.
- 2.7 Streets, Rights of Way and Access Plan (version P04 to supersede version P03 submitted on 9 October 2020). The change made is to show an access to the plot to the west and north of plot 4/20c as requested by Allow Ltd.

This will be submitted to the Examining Authority if and when it is received.
