1 Introduction

1.1 Purpose of this document

- 1.1.1 This Statement of Common Ground ('SoCG') has been prepared in respect of an application for a Development Consent Order ('the Application') under section 37 of the Planning Act 2008 ('PA 2008') for the proposed M54 to M6 Link Road ('the Scheme') made by Highways England Company Limited ('Highways England') to the Secretary of State for Transport ('Secretary of State').
- 1.1.2 This SoCG does not seek to replicate information which is available elsewhere within the Application documents. All documents are available on the Planning Inspectorate website.
- 1.1.3 This SoCG has been produced to confirm to the Examining Authority where agreement has been reached between the parties to it, and where agreement has not (yet) been reached. SoCGs are an established means in the planning process of allowing all parties to identify and so focus on specific issues that may need to be addressed during the examination.
- 1.1.4 This SoCG has been drafted by Highways England based on correspondence with Western Power Distribution during the development of the Scheme and records Highways England's current understanding of the matters agreed and not agreed.
- 1.1.5 The draft was provided to Western Power Distribution on 05 November 2020. In the absence of comments received from WPD, this version represents Highways England's understanding of the respective positions but is not a signed or agreed SoCG.
- 1.2 Parties to this Statement of Common Ground
- 1.2.1 This SoCG has been prepared by (1) Highways England as the Applicant and (2) Western Power Distribution (WPD).
- 1.2.2 Highways England became the Government-owned Strategic Highways Company on 1 April 2015. It is the highway authority in England for the strategic road network and has the necessary powers and duties to operate, manage, maintain and enhance the network. Regulatory powers remain with the Secretary of State. The legislation establishing Highways England made provision for all legal rights and obligations of the Highways Agency, including in respect of the Application, to be conferred upon or assumed by Highways England.
- 1.2.3 WPD is an electricity distribution network operator for the Midlands, South West and Wales. WPD serves approximately 7.7 million customers in its combined distribution areas.

1.3 Terminology

1.3.1 In the tables in the Issues chapter of this SoCG, 'Under discussion' indicates where these points are the subject of ongoing discussion, or where there has been little



- engagement but issues are not classed as "Agreed" or "Not Agreed". 'Agreed' indicates where the issue has been resolved.
- 1.3.2 It can be taken that any matters not specifically referred to in the Issues chapter of this SoCG are not of material interest or relevance to WPD, and therefore have not been the subject of any discussions between the parties. As such, those matters can be read as agreed, only to the extent that they are either not of material interest or relevance to WPD.
