#### 1 Introduction

#### 1.1 Purpose of this document

- 1.1.1 This Statement of Common Ground ('SoCG') has been prepared in respect of an application for a Development Consent Order ('the Application') under section 37 of the Planning Act 2008 ('PA 2008') for the proposed M54 to M6 Link Road ('the Scheme') made by Highways England Company Limited ('Highways England') to the Secretary of State for Transport ('Secretary of State').
- 1.1.2 This SoCG does not seek to replicate information that is available elsewhere within the Application documents. All documents are available on the Planning Inspectorate website.
- 1.1.3 This SoCG has been produced to confirm to the Examining Authority where agreement has been reached between the parties and where agreement has not (yet) been reached. SoCG are an established means in the planning process of allowing all parties to identify and focus on specific issues that may need to be addressed during the Examination.

#### 1.2 Parties to this Statement of Common Ground

- 1.2.1 This SoCG has been prepared by Highways England as the Applicant and Severn Trent Water Limited ("STW").
- 1.2.2 Highways England became the Government-owned Strategic Highways Company on 1 April 2015. It is the highway authority in England for the strategic road network and has the necessary powers and duties to operate, manage, maintain and enhance the network. Regulatory powers remain with the Secretary of State. The legislation establishing Highways England made provision for all legal rights and obligations of the Highways Agency, including in respect of the Application, to be conferred upon or assumed by Highways England.
- 1.2.3 STW is one of the largest of the 10 regulated water and sewerage companies in England and Wales. It provides water services to over 4.3 million homes and businesses in the Midlands.
- 1.2.4 This SoCG has been drafted by Highways England based on correspondence with STW during the development of the Scheme and records Highways England's current understanding of the matters agreed and not agreed.
- 1.2.5 The first draft (version 1 (P01)) was provided to STW on 25 August 2020.. A second draft was issued on the 03 November 2020. Highways England and STW have reached agreement on the protection it requires for its apparatus. When approving the agreement, STW confirmed that it had no further comments on the SoCG and that it is accepted as agreed. Highways England has updated all matters to 'Agreed' and submits it accordingly.

#### 1.3 Terminology

1.3.1 In the tables in the Issues chapter of this SoCG, 'Not Agreed' indicates a final position, and "Agreed' indicates where the issue has been resolved.



1.3.2 It can be taken that any matters not specifically referred to in the Issues chapter of this SoCG are not of material interest or relevance to STW, and therefore have not been the subject of any discussions between the parties. As such, those matters can be read as agreed, only to the extent that they are either not of material interest or relevance to STW.
