## 1 Introduction

### 1.1 Purpose of this document

- 1.1.1 This Guide to the Application (this 'Guide') is provided in relation to the M54 to M6 Link Road Scheme (the 'Scheme'). Highways England (the 'Applicant') has submitted an application under Section 37 of the Planning Act 2008 (the 'PA 2008') for an order granting development consent (a DCO) for the Scheme.
- 1.1.2 The purpose of this Guide is to help the Examining Authority (ExA) and interested parties understand the documents submitted as part of the application. The Guide identifies the latest version of any document that has been submitted as part of the Examination and indicates those documents which are to be certified. The Guide contains a full record of documents submitted to the Planning Inspectorate by the Applicant, including application documents that are not proposed to be certified and additional documents submitted after acceptance of the application in February 2020.
- 1.1.3 The documents identified with a 'y' in Table 1 replicate those listed in Schedule 10, 'Documents to be Certified' in the draft DCO [TR010054/APP/3.1].

## 2 Application Documents Submitted

- 2.1.1 Table 1 sets out all application documents submitted to the Planning Inspectorate by the Applicant. Table 1 tracks the latest version of the documents, with previous superseded versions greyed out and the text struck through.
- 2.1.2 Table 1 indicates those documents which are to be certified by the Secretary of State, additional application documents that are not to be certified and any new documents submitted at particular Examination deadlines. Note that all new and revised documents that relate to the application Volumes 1 to 7 are included in the relevant section in Table 1. The only exception to this is the Natural England Statement of Common Ground, which previously used to be document [TR010054/APP/7.3] and is now [TR010054/APP/8.8P(B)] so that it has the same numbering as other Statements of Common Ground. All new documents that do not relate to the application Volumes 1 to 7 are included in Volume 8 in Table 1.
- 2.1.3 Key plans are issued as plan sets with each set given a revision number in Table 1. Tables 2 to 12 in this Guide provide the full list of plan reference numbers in each set. For example, the Works Plans are listed under application document TR010054/APP/2.2 in Table 1, with the numbers for individual plans that make up this set provided in Table 5.
- 2.1.4 This revision of this Guide is being submitted to the Planning Inspectorate for Deadline 9. It follows the acceptance of the design changes by the Examining Authority on 29 October 2020 which has meant documents submitted with the Scheme changes on 9 October 2020 have now superseded previous versions. It also follows acceptance by the Examining Authority of a change to update the Land Plans to be consistent with other documents on 7 January 2021.
