The Inspectorate on behalf of the SoS has considered the Proposed Development which comprises the delivery of junction improvement works to increase capacity. Proposals include: the replacement of the circulatory roundabout with a 'dumbbell' roundabout; the conversion of the M3 south of Junction 9 to a dual three lane motorway; the realignment of slip roads; the addition of new structures (including facilitating the existing A34 to pass beneath the M3); and improvements to safety measures, signage and technology.		
The Inspectorate concludes that the Proposed Development <b>is unlikely to have a</b> <b>significant effect either alone or cumulatively on the environment in another</b> <b>European Economic Area State</b> . In reaching this conclusion the Inspectorate has identified and considered the Proposed Development's likely impacts including consideration of potential pathways and the extent, magnitude, probability, duration, frequency and reversibility of the impacts.		
The Inspectorate considers that the likelihood of transboundary effects resulting from the Proposed Development is so low that it does not warrant the issue of a detailed transboundary screening. However, this position will remain under review and will have regard to any new or materially different information coming to light which may alter that decision.
