Application by National Highways for an Order Granting Development Consent for the M3 Junction 9 Improvement Scheme.

Applicant's response to Rule 6 Letter of the 18 April 2023.

This letter is National Highways' (the Applicant) response to the Examining Authority's (ExA) Rule 6 letter dated 18 April 2023.

In advance of the Preliminary Meeting, in respect of the application for the M3 Junction 9 Improvement Scheme (the Application), the intention of this letter is for the Applicant to provide a brief update on the progress of the Application since submission.

This letter addresses a number of matters raised in the ExA's notice of the Preliminary Meeting (the Rule 6 Letter), to be discussed further at the Preliminary Meeting if necessary.

1. List of Proposed Attendees at the Preliminary Meeting and Subsequent Hearings

- 1.1. The Applicant will attend, and participate in, the Preliminary Meeting on Tuesday 16 May and encloses at Schedule 1 the full list of proposed attendees on behalf of the Applicant. The Applicant will be principally represented by Cathryn Tracey of Burges Salmon LLP.
- 1.2. The Applicant will also be attending all hearings listed at Annex 4 of the Rule 6 Letter and, following receipt of the relevant agendas, the Applicant will produce a list of proposed speakers and present this to the Planning Inspectorate in advance of the relevant hearing.
- The Applicant requests to be provided with the list of Interested Parties who have 1.3. indicated their intention to attend the Preliminary Meeting and Open Floor Hearing 1.

2. Open Floor Hearing 1: Wednesday 17 May 2023

- 2.1 The Applicant will attend the Open Floor Hearing 1 that has been scheduled for Wednesday 17 May 2023 and encloses at **Schedule 2** the full list of proposed attendees on behalf of the Applicant. The principal representative for the Applicant will be Cathryn Tracey of Burges Salmon LLP.
- 2.2 In lieu of an agenda being available the Applicant anticipates that the ExA will wish to use of the time at the Open Floor Hearing 1 to hear from members of the public. Accordingly, the Applicant is not anticipating responding in detail to parties at the Open Floor Hearing 1 nor provide any detailed statements but will provide responses to clarify issues should that assist the ExA. The Applicant will instead provide a written response to the representations made at the Open Floor Hearing 1 where necessary.
- 2.3 If this is not the expected level of participation at the Open Floor Hearing 1, the ExA is requested to clarify the involvement of the Applicant as the attendees at this hearing reflects the proposed approach.

3. Timetable for Examination

- 3.1 The Applicant has the following comments on the ExA's timetable:
 - The Applicant recognises that items 17 and 18 of the Draft Examination timetable fall within school holidays, and may impact representation from Interested Parties, Local Authorities and Statutory bodies. The ExA may wish to consider moving one week forward to Week Commencing 24 July 2023.
 - The Applicant's Landscape Visual Impact team are currently unavailable between 31 July and 11 August 2023 and would be grateful if hearings relating to Landscape and Visual Impacts are scheduled outside of this period.

4. Statements of Common Ground

- 4.1 Since acceptance of the Application, the Applicant has continued to work with a number of consultees to produce and develop Statements of Common Ground (SoCG). The Applicant notes the list of six interested parties the ExA has listed in Annex F of the Rule 6 Letter and confirm that these six SoCGs are being progressed, along with emphasis on the key topics listed by the ExA.
- 4.2 The Applicant notes the ExA request for submission of a 'Statement of Commonality for SoCGs' at Deadline 1, and initial SoCGs at Deadline 2. The Applicant submitted a document named **Progress with Statements of Common Ground (Document Reference 7.12) (APP-165)** with the Application submission and proposes to continue to update this document, as opposed to producing a new 'Statement of Commonality for SoCGs.' Can the ExA confirm that it accepts this proposal as the purpose of these documents is the same.
- 4.3 **Schedule 3** summarises the status of the six SoCGs.

5. Additional Submissions

- 5.1 It is noted in Annex F of the ExA's Rule 6 Letter that the following Additional Submissions have been accepted:

- 5.2 An updated draft DCO was also submitted at the same time as these documents in response to Section 51 advice. It is requested that the ExA confirm this has been accepted.

6. Landowner and Statutory Undertaker Negotiations

- 6.1 Following submission, the Applicant has continued to actively liaise with landowners affected by the project in an attempt to reach agreement.
- 6.2 The Applicant is also liaising with various statutory undertakers. It is anticipated that protective agreements or protective provisions for the statutory undertakers will be agreed during the course of the Examination.

7.1 The Applicant's suggestions for locations to include as part of the ASI are to be found at **Schedule 4**.
