We recognise that additional, important and relevant issues will likely continue to emerge during the examination and the scope of the examination will not therefore be constrained to those initial assessment of principal issues which we've highlighted and all important and relevant issues will be examined.

Now the applicants procedural deadline.

A submission points out the items 17 and 18 of the draft examination timetable. That is to say, the dates reserved for issue specific hearings fall within the school holidays and submits that this may impact representations from interested parties, local authorities and statutory bodies. The applicant suggests moving the dates reserved for issue specific hearings one week forward to week commencing 24th of July 2023.

The applicant also indicates that its landscape and visual impact team are currently unavailable between 31st of July and the 11th of August 2023, and would be grateful if the hearings relating to landscape and visual impacts is scheduled outside that period. If I can just comment from the examination examining Authority's considerations when that draft timetable was first put in place, we were aware of and did bear in mind any implications arising from the timetabling of the school holidays when preparing that draft timetable? We do, of course recognise the additional demands that this could place upon people with children of school age and indeed grandparents wishing to take part in the process.

However, the flexibility of the timetable is constrained to some extent by the fixed examination period and other statutory timetable timed timings for the receipt and consideration of documentation. The provisional issues specific hearing dates of week commencing 31st July and 11th of August reflect those factors and the need to allow time for the deadline three documentation to be fairly considered prior to those hearing dates.

So the best and most efficient use can be made of hearing time. We would also reiterate that representations made in writing carry equal weight to oral representations at all stages of the process, and that recordings of hearings and opportunities to comment will be made available after all events. Similarly, the availability or otherwise of a professional witness is not a matter which can take precedence over the demands of the examination and the efficient and fair timetabling of hearings within that process.
