1 Introduction

1.1 Purpose of this document

- 1.1.1 This Schedule of Changes to the Book of Reference (4.4) relates to an application made by National Highways (the Applicant) on 21 November 2022 under Section 37 of the Planning Act 2008 (PA 2008) for an order to grant development consent for the M3 Junction 9 Improvement Scheme (the Scheme).
- 1.1.2 The Development Consent Order (DCO) application was accepted for Examination on 15 December 2022. A detailed description of the Scheme can be found in Chapter 2 (The Scheme and its Surroundings) of the Environmental Statement (6.1, APP-043).
- 1.1.3 This Schedule of Changes should be read in conjunction with the Land Plans (2.2, APP-006) and updated Book of Reference (4.3, Rev 2) and Statement of Reasons (4.1, Rev 2) submitted alongside this document at Deadline 2, 15 June 2023.
- 1.1.4 The **Schedule of Changes** details all amendments to plots made on the Land Plans as well as changes in land ownership identified through a refresh of landowner and title data, information identified through ongoing engagement with land interests, and updates provided by the Examining Authority.
