About OFH1

This is the first Open Floor Hearing to be held in this Examination. It is being held to allow IPs to make oral representations about the application.

Attendance at the Hearing

The ExA is conducting this Hearing virtually in light of Government restrictions relating to Coronavirus (COVID-19), in particular the Omicron variant, using digital and telephone technology only.

Anyone wishing to attend the Hearing who has not already advised the Case Team of this should do so as soon as possible (and by **Monday 17 January 2022 at the latest**), as you will need to be issued with joining instructions to access the Hearing virtually. Parties can join using a computer, laptop, tablet, mobile phone or landline telephone. Invitees will receive full instructions on how to join online or by phone in a separate email shortly before the Hearing, including a joining link or telephone number through which you can join the Arrangements Conference. number are for your own personal use and **should not be shared with any other party**.

Please join the Arrangements Conference at the appointed time for the Hearing you have been invited to. The Case Team will admit you from the lobby and register your attendance. The Arrangements Conference allows procedures to be explained and will enable the Hearing to start promptly.

It is the Applicant's intention to livestream the Hearing, and a link to watch the livestream will be posted on the <u>project webpage of the Planning Inspectorate's</u>

<u>National Infrastructure Planning website</u> closer to the event date. A recording of the Hearing will also be made available on the project webpage shortly after the event.

Participation, conduct and management of Hearing

The Hearing will be subject to the powers of control of the ExA and we will be inviting registered participants to make an oral representation to us. You will see that, due to the number of requests to speak, each IP will be strictly limited to a maximum of 5 minutes. Please run through your representation in advance to ensure it can be completed within 5 minutes to avoid us having to cut your contribution short. To facilitate an efficient Hearing, we would also ask those with common points to come together and to nominate a spokesperson or representative speakers to cover specific topics, so as to avoid repetition.

As the Hearing will be recorded, please do not include any information that you wish to be kept private and confidential.

Each IP has been allocated a meeting and time to make their representation. If any IP has been invited to speak at a time when they are unable to attend, they should contact the Case Team as a matter of urgency to advise. The ExA therefore invites a contribution from each of the IPs that have registered to speak at this Hearing and as identified in **Annex A**.

Where two persons are named together, it would be helpful if one could be nominated to speak at the Hearing. Should both persons wish to participate, then they will need to share the allocated 5 minutes slot.

Breaks are provided during the OFH in recognition of the fatigue associated with onscreen communication during virtual events. Where an OFH has been divided into Sessions, those listed to speak in later Sessions may, if they wish, leave the Hearing after Item 1 below and then re-join the OFH as indicated in **Annex A** before the start of the appropriate Session.

All representations at the OFH should be based on the Relevant Representation or Written Representation made by the person by whom (or on whose behalf) the oral



representations are made². However, representations made at the Hearing should not simply repeat matters previously covered in a written submission. Rather, they should draw attention to those submissions in summary form and provide further detail, explanation and evidential corroboration to help inform the ExA.

The ExA may ask questions about representations or ask the Applicant or other party to comment or respond. Breaks may be taken during the Hearing as directed by the ExA. The Agenda is subject to change depending on, for example, responses from the invitees.

May we draw your attention to **Deadline 3** on the Examination Timetable **(Wednesday 2 February 2022)** and our request to receive full summaries of all oral submissions given at this Hearing by that date by those who made them. Note that any additional illustrative or supporting material that you wish to share must be submitted at Deadline 3, as it will not be possible for you to show it on screen during your contribution to the Hearing.
