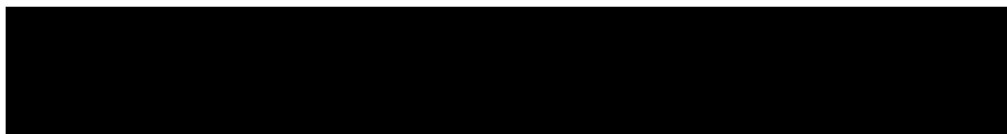

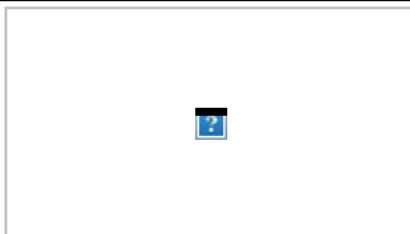
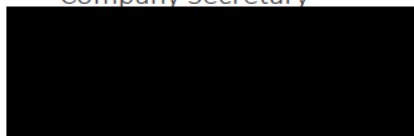
I can confirm that the CBA is not intending to attend in person on this occasion and that we hope that our written evidence is taken into account.
