#### 1 Introduction

#### 1.1 Purpose of this Document

- 1.1.1 This Guide to the Documents to be Certified (this "Guide") relates to an application made by Highways England (the "Applicant") to the Secretary of State for Transport via the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). If made, the DCO would grant consent for the A1 in Northumberland: Morpeth to Ellingham (the "Scheme").
- 1.1.2 The Scheme comprises two sections known as Part A: Morpeth to Felton (Part A) and Part B: Alnwick to Ellingham (Part B). A detailed description of the Scheme can be found in **Chapter 2: The Scheme, Volume 1** of the Environmental Statement (**Application Document Reference: TR010041/APP/6/1**).
- 1.1.3 The purpose of this Guide is to help the Examining Authority and interested parties understand the draft DCO (**Application Document Reference: TR010041/APP/3.1**) through identifying the latest version of any document that it is being asked to certify. It also aims to help the Examining Authority and interested parties understand the parameters for implementing the DCO and how it will be implemented.
- 1.1.4 This Guide has been submitted with the application and will be updated where necessary throughout the Examination to confirm:
  - i. Any revised versions of any application documents; and / or
  - ii. Any additional documents produced since submission of the application.

Were the Secretary of State to grant development consent, these documents would comprise the basis of the DCO.

1.1.5 The documents identified in the table below replicate those listed in Schedule 12, 'Documents to be Certified' in the draft DCO (**Application Document Reference:** TR010041/APP/3.1).
