1 INTRODUCTION

1.1 DOCUMENT SCOPE

- 1.1.1. This updated gazetteer supersedes the gazetteer provided in the **Historic Environment Desk Based Assessment (HEDBA) (Appendix 8.1, Volume 8** of this Environmental Statement (ES) (**Application Document Reference TR010041/APP/6.8**)) (completed in August 2019)) and relates to the design of Part B of the Scheme assessed as part of this ES. It is based on the data held in the National Heritage List for England (prefixed with NHL), the Northumberland Historic Environment Record (prefixed with HER) and identified during the course of the assessment (prefixed with WSP).
- 1.1.2. The updated gazetteer should also be read together with **Chapter 8: Cultural Heritage (Volume 3** of this ES (**Application Document Reference TR010041/APP/6.3**)) and the introductory chapters of this ES (**Chapters 1 to 4, Volume 1** of this ES (**Application Document Reference TR010041/APP/6.1**)), in particular **Chapter 2: The Scheme (Volume 1** of this ES).
- 1.1.3. Part B comprises of the widening of the existing A1 into a dual carriageway from Alnwick northwards to Ellingham (Part B Main Scheme Area), a construction compound located at Felton (Main Compound) and a construction compound located at Alnwick (Lionheart Enterprise Park Compound) which is split into two sites (eastern site and western site) which are located either side of the existing Highways England maintenance depot (refer to **Chapter 2: The Scheme, Volume 1** of this ES (**Application Document Reference TR010041/APP/6.1**)).
- 1.1.4. The updated gazetteer presents:
- a. The asset's reference number.
 - b. Name of the asset.
 - c. The designation of the asset.
 - d. The asset type (monument, findspot or built heritage).
 - e. Date of the asset (see **Table 1-1** below).
 - f. The location of the asset (inside or outside of the Order Limits of Part B).
 - g. The sensitivity/importance of the asset.
 - h. Magnitude of impact of the Part B on the asset.
 - i. Significance (i.e. the "effect") of the impact on the asset before mitigation measures are implemented.
 - j. Mitigation proposed (refer to **Section 8.9, Chapter 8: Cultural Heritage, Volume 3** of this ES (**Application Document Reference: TR010041/APP/6.3**)) for a description of the proposed mitigations for this topic).
 - k. Significance of Residual effects.
- 1.1.5. **Table 2-1** and **Table 2-2** presents the heritage assets in the Study Area for the Part B Main Scheme Area, **Table 3-1** and **Table 3-2** presents the heritage assets in the Study Area for the Main Compound and **Table 4-1** and presents the heritage assets in the Study Area for the Lionheart Enterprise Park Compound.

- 1.1.6. The location of all the heritage presented in the updated gazetteer is presented in **Figure 8.1: Designated Heritage Assets within 1 km of the Scheme** and **Figure 8.2: Non-Designated Heritage Assets within 500 m of the Scheme (Volume 6 of this ES (Application Document Reference TR010041/APP/6.6))**.

1.2 ASSESSMENT METHODOLOGY

- 1.2.1. The methodology for the assessment of the sensitivity/importance, the magnitude of impacts and the significance of the effect is outlined in **Section 8.4 of Chapter 8: Cultural Heritage, Volume 3** of this ES (**Application Document Reference: TR010041/APP/6.3**). It has been undertaken in accordance with the methodologies described in the following guidance documents:
- a. Historic Environment Good Practice Advice in Planning Policy Notes 2-3 managing significance and setting (**Ref. 1** and **Ref. 2**).
 - b. Design Manual for Roads and Bridges (DMRB), Volume 11, Section 3, Part 2 (DMRB: HA 208/07) (**Ref. 3**).
 - c. Highways Agency (now Highways England) Scheme Assessment Reporting Volume 5, Section 1, Part 2 (TA 37/93) (**Ref. 4**).
 - d. Chartered Institute for Archaeologists standards and guidance documents (**Ref. 5** and **Ref. 6**).
- 1.2.2. A summary of the British archaeological and historical periods and their corresponding dates is presented in **Table 1-1** below.

1.3 STUDY AREAS

- 1.3.1. The Study Areas were based on guidance outlined in DMRB Volume 11 Section 3 Part 2 HA 208/07 Cultural Heritage (**Ref. 3**) and agreed in consultation with Northumberland County Council (NCC).
- 1.3.2. Two Study Areas were used for the assessment. A wider Study Area was applied for the assessment of settings of designated heritage assets and Conservation Areas, and this extends up to 1 km from the Order Limits of Part B (**Figure 8.1: Designated Heritage Assets within 1 km of the Scheme, Volume 6** of this ES (**Application Document Reference: TR010041/APP/6.6**)). The extent of the 1 km Study Area was reviewed against the Zone of Theoretical Visibility (ZTV) Model (**Figure 7.1: Zone of Theoretical Visibility, Volume 6** of this ES) and during the site walk over survey. It was judged that due to the topography in the wider area, the distance and all the intervening visual barriers, no designated assets beyond the 1 km Study Area would be adversely impacted through a change in setting.
- 1.3.3. An inner Study Area of 500 m extending out from the Order Limits of Part B was applied for the identification of all types of heritage assets (designated, non-designated, potential archaeological remains and historic landscapes) to establish the known historic environment context and the potential for hitherto unknown below-ground archaeological remains (refer to **Figure 8.2: Non-Designated Heritage Assets within 500 m of the Scheme, Volume 6** of this ES (**Application Document Reference TR010041/APP/6.6**)). The quantity of data obtained within the 500 m Study Area was judged to be appropriate to inform the baseline and to adequately determine the potential for additional currently unknown assets within the Order Limits of Part B based on those found in the surrounding environment.
